8. Bonafide certificate on the format prescribed by the Board duly issued by the Controller/Registrar of the concerned University in respect of candidates, who have obtained Degrees from the Universities / Colleges/ Institutes outside the UT of J&K and other than Central Universities.
9. Migrant Certificate issued by Relief & Rehabilitation Commissioner.
10. Other documents and Certificates as prescribed in the Advertisement Notification and Qualification prescribed therein.
