Kindly refer to this office letter No.SSB/Sel/Secy/2021/7260-68 dated 21.10.2022 regarding the subject cited above, where-under the Selection List of candidates for the District Cadre posts of Class-IV, (Revenue Department), advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item Nos. 36, 37,38, 39, 40, 41,42, 43, 44 and 45, under Hon'ble Prime Minister's Package for Kashmiri Migrants and Non- Migrant Kashmiri Pandits, was forwarded to your department for further course of action.

Among the selectees, one candidate namely Mr. Meeru Daman Raina, figuring at S. No. 377/RBA, represented that his father's name was wrongly recorded in the said selection list as Vinod Kumar Raina instead of Vinod Raina. The request of the candidate was examined and it was found corroborating with the records available in this office and, accordingly, vide letter No.JKSSB-SD/11/2023-03(E-7174006) dated 08.06.2023, the above position was conveyed to your department, albeit the particulars were again mentioned wrongly as Vinod Kumar instead of Vinod Raina.

In view of the above, the undersigned is directed to request that father's name as recorded in the aforementioned Selection List in respect of Sh. Meeru Daman Raina, figuring at Sr.No 377/RBA, may be read as "Vinod Raina instead of Vinod Kumar Raina."

The other terms and conditions of the recommendation as communicated vide letter No. SSB/Sel/Secy/2021/7260-68 dated 21.10.2022 shall remain the same.
