**Notification**

Whereas, the Labour and Employment Department vide Indent No. L&E/Gen/53/2019-I Dated 30.09.2020 and vide Indent No. L&E/Gen/53/2019-I Dated 04.12.2020, among other posts, forwarded the requisition for making direct recruitment to the posts of **Labour Inspector** and **Labour Officer**, under Item Nos. 66 and 72 respectively, as per the following break up:

Whereas, as per the Indent/letter from the Indenting Department, the prescribed qualification for these posts are/were:

**(a) For the post of Labour Inspector:**

- "i) *Essential: Degree in Arts or its equivalent qualification from any university.*
- ii) *Desirabilities: Degree in Economics or Commerce or Sociology or its equivalent qualification of any recognized university."*

**(b) For the post of Labour Officer:**

*"Degree with Economics or Commerce or Sociology or Diploma in Social Work/Labour Welfare or Personnel Management or Industrial Psychology from recognized university or institute."*

**Whereas**, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid posts, among other posts, vide Notification No. 04 of 2020 dated 16.12.2020. As per the notified criteria, the selection to these posts was to be made in the following manner:

**Marks obtained in the written test out of maximum marks that shall be proportionately converted into points = 80, Viva Voce = 20, Total = 100;** and

**Whereas**, the JKSSB conducted the Computer Based Test (CBT) for these posts on 06.02.2023 and thereafter the result for these posts was notified on 31.05.2023 vide notification No. JKSSB-COE0EXAM(UT)/06/2023-04 (7110979) dated 31.05.2023. The Document Verification committees for the aforesaid posts were constituted vide order No. 56-SSB of 2024 dated 02.02.2024; and

**Whereas**, the Document Verification for the post of Labour Officer was held on 05.02.2024 and Document Verification for the post of Labour Inspector was held on 12.02.2024 at Jammu and Kashmir, respectively. Supplementary DV Committees for the left-out candidates were also constituted vide Order No. 67-SSB of 2024 dated 09.02.2024 and the supplementary DV was held on 12.02.2024. The Interview/Viva Voce for the post of Labour Officer (UT Cadre) was conducted vide Notice No. JKSSB-ADM-23/2024-23(E-7418850) dated 28.02.2024 on 05.03.2024 at 11 am and for the post of Labour Inspector was conducted vide Notice No. JKSSB-ADM-23/2024-23 (E-7418850) dated 28.02.2024 on 05.03.2024 at 2 pm at Central Office, Jammu, by the committee constituted vide Order No. 99-SSB of 2024 dated 04.03.2024; and

**Whereas**, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No. 105-SSB of 2024 dated 06.03.2024; and

**Whereas**, the Provisional Selection Lists prepared by the Selection Committee constituted for the above-mentioned posts, in light of the extant rules were approved by the Board in its 264<sup>th</sup> Board Meeting held on 06.03.2024 and subsequently notified vide Notification No. JKSSB-Scry/7/2024-03(E-7428732) dated 07.03.2024; and

**Whereas**, the candidate(s) aggrieved with the Provisional Selection Lists were asked to represent through the email address **labourofficerinspector@gmail.com** within **three** days from the date of notification of the Provisional Selection List. As no representation was received on the said Provisional Selection lists, the Final Selection Lists for the posts of **Labour Inspector**, under Item No. 66 (UT cadre) and **Labour Officer** under Item No. 72 (UT cadre), Labour and Employment, advertised vide Advertisement Notification No. 04 of 2020 dated 16.12.2020 was approved by the the Board in its 265<sup>th</sup> Board Meeting held on 11.03.2024.

**Now, therefore:**

- (i) The Final Selection Lists for the 03 posts of **Labour Inspector**, UT Cadre, under Item No. 66, and 03 posts of **Labour Officer**, UT Cadre, under Item No. 72, of Labour and Employment Department, advertised

vide Advertisement Notification No. 04 of 2020 dated 16.12.2020, is hereby notified as **Annexure-A** and **Annexure-B** respectively to this Notification.

(ii) The above Final Selection Lists shall be subject to the outcome of writ petition(s)/OAs, if any, pending in any Court of Law of the competent jurisdiction.

(iii) The Final Selection Lists shall also be subject to the outcome of pending inquiry, if any, involving candidate(s), figuring in this Selection List.

(iv) These Lists are provisional only, and mere figuring in the aforementioned lists shall not confer any right on the candidates for final selection.

(v) The formal recommendations to the concerned Indenting Department shall be forwarded separately.

(vi) The selection of the candidates has been made on the basis of self-declaration /Certificates submitted by them and if at any stage, it comes to light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/Certificates, the selection shall be liable to cancellation at any stage.
