The JKSSB conducted the Computer Based Test (CBT) for these posts and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted by the DV Committees constituted vide Order No. 35-SSB of 2022 dated 04.02.2022. After seeking preferences from the candidates and on the basis of the principle of Merit-cum-Preference, the Provisional Selection List for the said post was notified vide notification No. SSB/Secy/Sel/2022/6287-6300 dated 20.10.2022.

The above Selection list shall be subject to the outcome of writ petition(s), if any, pending disposal before any competent Court of jurisdiction related to the selection.



The Selection List shall also be subject to the outcome of any inquiry, involving candidate(s), figuring in this Selection List.
