Subject: T.A No. 61/3516/2020 titled Meera Rani V/s State of J&K and other. Disposal of representation thereof.

Whereas, the Jammu and Kashmir Services Selection Board advertised various posts of Junior Lab Technician in Health and Medical Education Department, District Cadre Jammu vide Advertisement Notification No. 06 of 2013, Item No. 462 dated 10.05.2013; and

Whereas, the Jammu and Kashmir Services Selection Board after completion of the selection process, issued the Selection List and forwarded the same to the Indenting Department vide communication No. SSB/Sel/Secy/15/3602-08 dated 30.11.2015; and

Whereas, the applicant figured at serial no. 01/OM in the Waiting list, feeling aggrieved of one post kept blank for want of clarification in the Selection List for the post of Junior Lab Technician at Serial No. 07 under OM category filed writ petition bearing SWP No. 2351/2017 before the Hon'ble High Court, Jammu which was later transferred to the Hon'ble Tribunal vide TA No. 61/3516/2020 titled Meera Rani V/s State of J&K and others and the Hon'ble Tribunal vide order dated 11.08.2021 disposed of the T.A and the operative para of the order is reproduced as:-

“Accordingly, in view of the submission of the parties, we dispose of the T.A. with direction to the competent authority amongst the respondents to consider the case of the applicant (Meera Rani) as well as Respondent No. 5 (Priyanka Kesar) for appointment to the post of Junior Lab Technician on the basis of advertisement notice No. 06 of 2013 dated 10.05.2013 as per rule and regulations and take a decision by passing a reasoned and speaking order within a period of two months from the date of receipt of a certified copy of this order”.

Whereas, a Sub-Committee has been constituted for examining the issues pertaining to TA No. 61/3516/2020 titled Meera Rani Vs State & Others and upon examination, the matter was taken up with the Para Medical Council of India, Karnal Haryana vide communication No. SSB/Legal/M-27/2020/1662-63 dated 28.01.2022 requesting to intimate whether the said candidate has done Diploma in distance mode or

regular mode and also furnish recognition status of the institute and genuineness of the Diploma certificate. A letter has also been written to Registrar, Department of Medical Education and Research Haryana, Panchkula, for verification of one year Diploma certificate in Medical Laboratory Technology of Ms. Priyanka Kessar (private respondent) and affiliation/registration status of Punjab Institute of Paramedical Science, Mukerian, Hoshiarpur (Punjab);and

Whereas, the response is awaited from the concerned quarters and in the meanwhile, the General Administration Department vide communication GAD-MTGORBIV/200/2021-09-GAD 03.02.2022 conveyed the Administrative Council Decision No. 01/01/2022 dated- 29.01.2022 which reads as under:-

" All posts referred to JKPSC/JKSSB prior to 31,10.2019, for which selections have not been finalized till date, as also the post in which there are litigations and the cases are pending in Hon'ble Courts, shall be deemed to have been withdrawn with immediate effect."

Whereas, the case of the applicant and the private respondent has been examined in the Board with the relevant record and rules prevailing in the field, and it was found that the present case has falls within the preview of Administrative Council Decision No. 01/01/2022 dated- 29.01.2022 and therefore, the relevant post stands withdrawn to the indenting department.

Now, therefore in deference to the order dated 11.08.2021 passed by the Hon'ble Tribunal in TA No. 61/3516/2020 titled Meera Rani V/s state of J&K and others, the case of the applicant has been considered in light of Administrative Council Decision No. 01/01/2022 dated- 29.01.2022 and is found without any merit, hence rejected.
