**Order No: 81 - SSB of 2023
Date: - 20 .04.2023**

Subject: O.A .No.61/ 272 /2023 titled Tasleem Akhter Vs UT of J&K and other
Disposal of representation thereof.

Whereas, the Jammu and Kashmir Services Selection Board advertised various posts of Junior Staff Nurse/Junior Grade Nurse, Health and Medical Education Department, District, Divisional and UT Cadre of J&K vide Advertisement Notification No. 02 of 2021 dated 26.03.2021; and

Whereas, the Jammu and Kashmir Services Selection Board after completion of the selection process, issued the Selection List and forwarded the same to the Indenting Department ;and

Whereas, the applicant aggrieved of non-selection had file O.A. before the Hon'ble Central Administrative Tribunal, Jammu which was disposed of by the Hon'ble Tribunal on 17.03.2023 with the following directions:-

"As a limited prayer is being made, the applicant is granted liberty to prefer a comprehensive representation to the competent respondent authority within a period of two weeks from the date of receipt of a copy of this order. Once so received, the said competent respondent authority is directed to examine the said prayer of the applicant in accordance with law as well in the light of the terms and conditions set forth in the notification No. 02 of 2021 and to decide on the prayer of the applicant. Such decision should be conveyed to the applicant in the form of a reasoned order within a period of six weeks thereafter. It is made clear, however, that this Tribunal has not entered into the merits of the matter and all issues to be raised by the applicant are left to be decided by the respondents in accordance with law. With these directions, the OA is disposed of. There will be no orders as to costs."

Whereas, in compliance to the aforesaid directions, the case of the applicant was examined with the relevant records and rules prevailing in the field and found that none of the posts for which the candidate has applied are suitable for the type of disability (Blindness/low vision) the applicant have for a particular post as per Government Order No 59-JK(SWD) of 2021 dated 15.04.2021 of Social Welfare Department; and

Whereas, the Health and Medical Department vide communication No. ME-NG/ 83/2022-02 dated 25.04.2022 clarifies with regard to the benchmark disabilities that reservation of PWD candidates are for only those posts enumerated in Government Order No 59-JK(SWD) of 2021 dated 15.04.2021 of Social Welfare Department, which talks about the


suitability of a type of disability for a particular post. And since none of the posts for which the candidate has applied are mentioned in Government Order, it clearly indicated that a person with disability is not suited for the posts of nursing domain she has applied for and she does not qualify the cut off as an open merit or ST candidate.

Whereas the merit position of the applicant Tasleem Akhter, D/o Raj Mohd is as under:-
