NOTIFICATION

Subject: Cancellation of withheld recommendation of Mr. Deepak Mattoo and Ms. Varsha Rani for the post of "Class IV", Item Nos. 36 to 45, advertised vide Notification No. 03 of 2020 dated 01.12.2020, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.

Whereas, the J&K Services Selection Board notified the Final Select list of "**Class IV**" posts advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item No. 36, 37, 38, 39, 40, 41, 42, 43, 44 and 45, under the Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits and forwarded the same to the Intending Department vide this Office letter No.SSB/Secy/Sel/2021/7260-68 dated 21.10.2021, for further course of action; and

Whereas, among others, the recommendation of Mr. Deepak Mattoo and Ms. Varsha Rani was kept withheld subject to production of valid Migrant Certificate in respect of Mr. Deepak Mattoo and subject to clarification with regard to name variation in Domicile and other documents in respect of Ms. Varsha Rani; and

Whereas, a Notice was served to these candidates for submission of pending documents vide No.SSB/Secy/Sel/2021/M/VI/3194-95 dated 23.03.2022, which did not evoke any response. Further, vide letter No. JKSSB/20/2022-01/603-607 dated 16.05.2023 and No. JKSSB/20/2022-01/596-600 dated 16.05.2023, Final Notices were served upon these candidates, but they again failed to submit the requisite documents within the prescribed time; and

Whereas, the above cases were placed in 232nd Board Meeting and the Board decided to cancel the candidature of Mr. Deepak Mattoo and Ms. Varsha Rani for non-submission of requisite documents, despite availing sufficient time.

Now therefore, the withheld recommendations of Mr. Deepak Mattoo and Ms. Varsha Rani for the post of "**Class IV**" advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item No. 36, 37, 38, 39, 40, 41, 42, 43, 44 and 45, under the Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits, are hereby **cancelled**.
