Whereas, the Department of Horticulture, vide Indent No. Horti/56/2017 dated 15.10.2020 and No. Horti/56/2017-Part file dated 18.02.2021, among other posts, forwarded the requisition for **28 posts of Senior Horticulture Technician** for making direct recruitment, with the following category-wise break-up:

Whereas, above 28 posts, belonging to Divisional Cadre, Jammu (12 Posts) and Divisional Cadre, Kashmir (16 Posts) were advertised by the Board vide Notification No. 01 of 2021 dated 03.02.2021, under Item Nos. 25 and 63 respectively, for seeking applications from the eligible candidates and the cut-off date i.e. last date for applying for these posts and for purpose of determining the eligibility/academic qualification, validity of category certificates and other such documents of the candidates was **29.03.2021**; and

Whereas, as per the Indent, the qualification prescribed for the said posts of Senior Horticulture Technician in Horticulture Department is ***"B.Sc. Horticulture OR B.Sc. Agriculture with Horticulture as major subject."***

Whereas, in terms of the notified Selection criteria, the selection for these posts was to be made on the basis of the Written Examination only and, accordingly, the JKSSB

conducted Computer Based Test (CBT) on 07.02.2023 as per Notice No. JKSSB-COE0EXAM(UT)/10/2022-04(CC-7055504) dated 06.01.2023. On the basis of performance of the candidates in the CBT, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/06/2023-04(7110979) dated 28.06.2023, published the Result/Score sheet of the candidates. After the publication of Result/Score Sheet, the preferences were sought from the candidates vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 20.07.2023 and simultaneously, the candidates falling under the consideration zone, were called for Document Verification (DV) vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03 (7207093) dated 20.07.2023 & Supplementary Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 09.08.2023; and


Whereas, after the conduct of the Document verification (DV) by the respective DV Committees, both at Srinagar and Jammu, the Board constituted a Selection Committee vide Office Order No. 164-SSB of 2023 dated 28.08.2023 to finalize the selection for these 28 posts of Senior Horticulture Technician, Division Cadre, Jammu/Kashmir, advertised vide Notification No. 01 of 2021 dated 03.02.2021, under Item Nos. 25 and 63; and

Whereas, the Selection Committee, constituted for these posts, observed and placed various issues regarding the selection for deliberations in the Board in its 242nd Board meeting, and after decision on the issues so flagged, prepared the Provisional Selection List as per the extant rules governing the subject and placed the same in the Board for approval; and

Whereas, after approval in the Board, in its 247th meeting held on 28.11.2023, the Provisional Selection List for the aforesaid posts of Senior Horticulture Technician, Level 6E; (Item No. 25/Divisional Cadre, Jammu and Item No. 63/Divisional Cadre, Kashmir), as received from the Horticulture Department, was notified vide No. JKSSB-PLAN/27/2023-03 (E-7283041) dated 08.12.2023, wherein one post under ALC/IB category was kept unfilled as no candidate was eligible/fulfilling the benchmark for selection for the said vacancy; and

Whereas, the above Provisional Selection list *inter-alia* provided that any candidate feeling aggrieved with it, shall represent with objections, if any. After due examination and scrutiny of the representations received in response to the notification of the Provisional Selection List, the Selection Committee framed the Final Selection List for these posts of Senior Horticulture Technician, which was subsequently approved in 253rd Board Meeting held on 05.01.2024.

Now, therefore, the Final Selection List of candidates for the posts of *Senior Horticulture Technician*, Level-6E (Divisional Cadre, Jammu, Item No. 25; Divisional Cadre,



Kashmir, Item No. 63), of Horticulture Department, advertised vide Notification No. 01 of 2021 dated 03.02.2021, is hereby notified as per **Annexure-A** to this Notification. One post under ALC/IB category for Item No. 063 (Divisional Cadre, Kashmir) has remained unfilled. It is further ordered that:

- (1) The above Final Selection List shall be subject to outcome of the OAs/Writ Petition(s), if any, pending adjudication before any Competent Court of law.
- (2) The List shall also be subject to the outcome of such *enquiry*, involving any candidate(s), as figuring in this List.
- (3) Formal recommendations to the concerned Indenting Department shall be forwarded separately.
- (4) The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.


