
Kindly refer to this office letter No. SSB/Sel/Secy/2022/5950-54 dated 06.09.2022 regarding the subject cited above, where-under the Selection List for the post of Motor Vehicle Traffic Assistant, Item No.087, 091 & 095 of Transport Department, advertised vide Notification No.04 of 2020 dated 16.12.2020, Divisional Cadre, Kashmir/ Jammu and UT Cadre was forwarded to your department for further course of action.
