Subject: O.A No. 61/1522/2023 titled Princy Sharma V/s UT of J&K and others.

Whereas, the Jammu and Kashmir Services Selection Board advertised the posts of Sub Inspector, Home Department UT Cadre advertised vide Advertisement Notification No. 06 of 2021 dated 01.07.2021; and

Whereas, the Jammu and Kashmir Services Selection Board conducted the written examination (CBT mode) for the aforesaid posts which was held from 07th December 2022 to 20th December 2022; and

Whereas, the Jammu and Kashmir Services Selection Board declared the result/scoresheet of the examination vide No. JKSSB-COE0EXAM(UT)/54/2022-03(7057013) dated 03.11.2023 ; and

Whereas, the applicant (Princy Sharma) filed O.A before the Hon'ble Central Administrative Tribunal Jammu and the Hon'ble Tribunal vide Order dated 24.11.2023 disposed of the OA, the operative portion whereof reads as under:-

"Accordingly, the Original Application is disposed of with a direction to respondents to treat this O.A. as representation of the applicant and decide the same by passing a reasoned and speaking order. 4. Respondents are further directed to communicate the order so passed to the applicant. Before passing any order, the applicant shall also be afforded an opportunity of hearing. The whole exercise shall be undertaken within a period of four weeks from the date of receipt of a certified copy of this order. 5. Applicant if found eligible, should be called for the physical standard test. 6. With these directions, O.A. No. 1522 of 2023 is disposed of. 7. It is made clear that, I have not entered into the merits of the case. 8. No orders so as to costs."

Whereas, Ms. Princy Sharma D/o Sh. Parshotum Sharma had applied for the post of Sub-Inspector, advertised under Notification No. 06 of 2021 under



OM category and has secured 33.89917 normalized marks and falls at overall S.No. 60653 based on her performance in the CBT for the post of Sub Inspector, Home Department under Roll No. 8113224174; and

Whereas, as per the criteria adopted by the Board, the shortlisting of candidates was done as per S.O. 214, dated 1st July, 2021, for selecting candidates for appearing in the PST/PET in the ratio of 1:6 (six times the total no. of vacancies) in each category; and


Whereas, the applicant applied under Open merit category and the last candidate under open merit category at S.No. 3606 has secured 99.39435 marks which are far more than the merit of the applicant under OM; and

Whereas, the list of 73 candidates (private respondents) given in the O.A. were shortlisted under Ex-Serviceman (ESM) category and the claim of applicant Ms. Princy Sharma projected in the original application found to be baseless, devoid of merit and beyond logic, as she secured much less marks than the last shortlisted candidate for Physical Endurance Test/Physical Standard Test (PST) and no comparison can be drawn with those having applied under reserved category; and

Whereas, the representation of the applicant has been considered in light of directions passed by the Hon'ble Tribunal and the applicant has been called and afforded an opportunity of hearing on 13.12.2023 and the facts explained to her.

Now, therefore, in view of above stated facts and circumstances of the case and in due deference to the Order dated- 24.11.2023 passed by the Hon'ble Tribunal Jammu, the case of the applicant has been considered and found devoid of any merit, hence rejected.
