S u b : - Selection of the candidate for the post of "Accounts Assistant" (Panchayat)" (Department of Rural Development and Panchayati Raj), advertisement vide Notification No.02 of 2020 dated 06-07-2020 under Items No.01 to 20 for all Districts of J&K Union Territory.

Whereas, the J&K Services Selection Board issued the Selection List of the candidates for the post of "Accounts Assistant" (Panchayat)" (Department of Rural Development and Panchayati Raj), advertised vide Advertisement Notification No.02 of 2020 dated- 06-07-2020 under Items No.01 to 20 for all Districts of J&K Union Territory and recommended the same to the Intending Department vide this Office communication No. SSB/Secy/Sel/2021/4866-72 Dated- 08-07-2021 for further course of action; and

Whereas, the selection of the candidates namely 1) Sameer Ahmad Khan S/o Sh. Bashir Ahmad Khan (Sr. No. 50/RBA/HCL). 2) Shahid Mohammad Maqbool Mir S/o. Sh. Mohammad Maqbool Mir (Sr. No. 56/OM/HCH). 3) Mohd. Qasim S/o. Ghulam Hussain (Sr. No. 59/ST/HCH) was kept withheld in light of directions dated- 28.05.2021 passed by the Hon'ble Central Administrative Tribunal, Jammu in O.A No. 824/2021 titled Gourav Sharma and Others V/S Rural Development UT of J&K, which reads as under:- " In the meanwhile, the appointment of Respondent No. 4 to 7 pursuant to the Select list dated- 10.05.2021 is stayed till the next date of hearing."

Whereas, the Hon'ble Tribunal on 19.04.2023 dismissed the above titled O.A with the following directions:- " In view of the discussion herein above the O.A lacks merits, therefore, the O.A. dismissed. No costs. "; and,

Whereas, the applicant/petitioner challenged the order/judgment dated- 19.04.2023 passed by the Hon'ble Tribunal in the Hon'ble High Court by filing writ petition bearing WP(C) No. 1370/2023 title Gourab Sharma vs UT of J&K and others; and

Whereas, the Hon'ble High Court on 26.05.2023 passed the following directions:-

" In the meanwhile, it is provided that the selection and appointment of respondent no. 4 to 7, if made, shall remain subject to the outcome of the instant petition. "; and

Whereas, the case of the candidates was placed before the Board in its 232nd Board meeting and after threadbare discussion it was decided to release of withheld recommendation of the above candidates; and,

Now, therefore, in light of the aforesaid facts here in above, the withheld recommendation of 1) Sameer Ahmad Khan S/o. Sh. Bashir Ahmad Khan (Sr. No. 50/RBA/HCL). 2) Shahid Mohammad Maqbool Mir S/o. Sh. Mohammad Maqbool Mir (Sr. No. 56/OM/HCH). 3) Mohd. Qasim S/o. Ghulam Hussain (Sr. No. 59/ST/HCH) for the post of "Accounts Assistant" (Panchayat)" (Department of Rural Development and Panchayati Raj), advertised vide Notification No.02 of 2020 dated- 06-07-2020 under Items No.01 to 20 for all Districts of J&K Union Territory is hereby released and forwarded to the Indenting Department for further action in the matter.

However, other terms and conditions conveyed vide letter No. SSB/Secy/Sel/2021/4866-72 Dated 08-07-2021, shall remain the same.

The recommendation released shall be subject to the outcome of the aforesaid writ petition pending before the Hon'ble High Court Jammu.
