Subject: Cancellation of candidature and debarment of candidate namely Arshid Ali.

Order No. 302-SSB of 2023

Dated: 07.12.2023

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) conducted the Computer Based (CBT) Examination for the post of Sub-Inspector (Home Department), UT Cadre at various Examinations Venues/Centres from 07.12.2022 to 20.12.2022 in multiple sessions/shifts; and


Whereas, a candidate namely Arshid Ali S/o Mohd Sadiq R/o NarwalBala, Tehsil Bahu, Jammu, 181152, appeared in the said examination under Roll No. 8112210064 on 12.12.2022 in 2nd Shift at A.V Institute of Nursing and Medical Sciences, Marbel Market Road, behind City Farms, Jammu; and

Whereas, the said candidate has misbehaved with the invigilator and disobeyed the instructions of the supervisory staff with the intent of creating disturbance in the examination hall as reported by the concerned Observers/Officials deployed thereby resorting to unfair means while answering the question paper in the lab/room as reported by the site supervisor and General Observer; and

Whereas, vide No. JKSSB-COE0Exam(UT)/39/2023-03 dated 15.11.2023, a show cause notice was issued to the said candidate to explain his position. The reply to the said show cause notice was submitted by the candidate on 16.11.2023 and was examined in the light of relevant Rules/Regulations; and

Whereas, the case was placed before the Unfair Means Committee constituted in terms of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022 under part XXX (67), and the committee, after considering the nature of the offense and evidence brought on record, recommended as under:-

"The committee observed that the candidate has committed offense under section 65(b) of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, and therefore the committee recommends cancellation of the candidature for the said post, besides debarment for a period of six months for all examinations conducted by JKSSB w.e.f. date of examination i.e. 12.12.2022"




Whereas, the recommendations of the committee were placed before the 247th Board Meeting held on 28.11.2023 and the following decision was taken:-

"The Board considered the report and accepted the recommendations of the Unfair Means Committee w.r.t. the unfair means case involving the candidate namely Arshid Ali S/o Mohd Sadiq in the CBT Examination held for the post of Sub-Inspector(Police), Home Department advertised vide Notification No. 06 of 2021 dated 21.10.2021, with the modification that the period of debarment of six months shall commence from the date of issuance of an order in this regard".

Therefore, in view of the above and as per section 69 of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, the candidature of candidate namely Arshid Ali S/o Mohd Sadiq for the post of Sub-Inspector (Police) Home Department advertised under Notification No. 06 of 2021 dated 21.10.2021 is hereby cancelled. The candidate is further debarred from appearing in all the examinations to be conducted by the Board for a period of six months from the date of issuance of this order.
