**NOTIFICATION**

Subject: Cancellation of withheld recommendations of Ms. Anita Thusoo/Raina and Mr. Sarub Jeet Singh for the post of "Assistant Compiler" (Finance Department), Divisional Cadre, Kashmir, advertised vide Notification No. 03 2020 dated 01.12.2020, Item No. 022, under PM Package.


Whereas, the J&K Services Selection Board notified the Final Selection List for the posts of "Assistant Compiler", (Finance Department), Divisional Cadre, Kashmir, advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item No. 022, under PM Package and forwarded the same to the Intending Department vide this Office letter No. SSB/Sel/Secy/M/03/2021/6314-20 dated 23.09.2021, for further course of action; and

Whereas, among others, the recommendation of Ms. Anita Thusoo/Raina, Sr. No. 60 /EWS (Selection List) and Mr. Sarub Jeet Singh at Sr. No. 389/OM (Selection List), were kept withheld subject to production of EWS Certificate in respect of Ms. Anita Thusoo/Raina and subject to production of Migration Certificate in respect of Mr. Sarub Jeet Singh; and

Whereas, the First Notice was served upon these candidates for submission of pending documents vide No. SSB/Secy/Sel/2021/M/C/03/3192-93 dated 23.03.2022 which did not evoke any response. Further, vide No. JKSSB-SDOSECY (MIG)-01 (211339) dated 01.09.2023 and No. JKSSB-SDOSECY(MIG) -01 (211339) dated 04.09.2023, the Final Notices were served upon these candidates. While Ms. Anita Thusoo/Raina submitted her EWS Certificate, which has, however, been issued after the cut-off date i.e. 25.01.2021 rendering her Ineligible for the post, Mr. Sarub Jeet Singh has not submitted any documents within the prescribed time; and

Whereas, the above cases were placed in 247th Board Meeting which decided to cancel these withheld recommendations; and

Now, therefore, the withheld recommendations of Ms. Anita Thusoo/Raina and Mr. Sarub Jeet Singh for the post of "Assistant Compiler", (Finance Department), Divisional Cadre, Kashmir, advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item No.022, under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits, are hereby cancelled.
