EXTENSION NOTICE



Accordingly, as a one-time exception, in the interest of the candidates, the following is notified:

1. The date for submission of application forms for the posts of Supervisor, Social Welfare Department, advertised vide Notification No. 02 of 2023 dated 08.12.2023, is hereby extended as under:

2. The Edit Option for allowing change in various particulars shall also be activated from 21.03.2024 (8:00 AM) to 23.03.2024 (8:00 PM). *As a one time opportunity, the Edit Option shall include "**Item Option**" also, in addition to the normal fields being provided to the candidates.*
3. No change, beyond the above timelines, shall be permitted for whatsoever reasons.
4. The candidates, in their own interest, are advised to submit the application forms, complete in all respects, without waiting for the last date to avoid last minute disruptions.
