**Subject: Final Selection List for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021-Forwarding of recommendations thereof.**

Sir,

Consequent upon the receipt of the Indents dated 02.07.2021 and 23.11.2021 from the Home Department, the J&K Services Selection Board (JKSSB) vide Notification No. 06 of 2021 dated 21.10.2021, read with Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021, advertised **1200 Posts** of Sub-Inspector, Police, UT Cadre, with the following category-wise break-up:

In terms of the notified criteria, the selection for these posts was to be made on the basis of the Written Test, followed by Physical Standard Test(PST)/Physical Endurance Test(PET), with additional weight-age assigned to the candidates in possession of NCC Certificates. The JKSSB, accordingly, conducted the Computer Based Written Test (CBT), followed by conduct of the Physical Standard Test (PST)/Physical Endurance Test (PET) of the shortlisted candidates and subsequent Document Verification of the candidates falling in the consideration zone.

The concerned Selection Committee constituted by the Board, having regard to merit/eligibility of the candidates and various other aspects attendant to the selection including medical reports from the concerned Medical Boards and as per the extant procedure/regulations, framed the Final Selection List for these posts, which was subsequently notified vide Notification No. 01-Selection of 2024 dated 8<sup>th</sup> of January, 2024, under endorsement No. JKSSB-Scry/26/2023-03(E-7376857) and forwarded to the Indenting Department, containing the recommendation of 1102 candidates, vide communication No. JKSSB-Scry/26/2023-03(E-7376857) dated 10.01.2024.

In the aforesaid Selection List, 98 posts were kept *Reserved*, out of which 71 reserved posts were filled up and forwarded to the Indenting Department vide letter No. JKSSB-Scry/26/2023-03(E-7376857) dated 05.02.2024, thereby leaving a balance of 27 posts. Out of these 27 cases, the case of Mr. Pardeep Kumar, S/o Bawa Ram, R/o Kotli Mirdian, Jammu, Suchetgarh, Korotana, 181102 (Application ID 1408823), was referred to Health and

Medical Education Department for the conduct of Medical Examination. Consequent upon the receipt of satisfactory medical report, the matter was placed before the Board in its 264<sup>th</sup> meeting, which after deliberations and consideration of the matter, decided to fill up the reserved post by considering the candidature of the eligible candidate and recommend to the Indenting Department

Accordingly, the undersigned is directed to forward herewith the Final Selection List for 01 post which was kept reserved earlier, for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021, Item No. 668, as per **Annexure-A** to this communication.

The above Selection List shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Selection List shall also be subject to the outcome of any *inquiry*, involving candidate figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.


The Selection of the candidate has been made on the basis of Self-declaration/Certificates submitted by him and if at any stage, it comes to the light that the candidate has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against the candidate may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidate, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate shall forego their right to appointment forthwith.
