***“Accordingly, the Original Application is disposed of, at the admission stage itself, without entering into the merits of the case, with a direction to respondents to treat a copy of this Original Application as applicant representation and decide the same by passing a reasoned and speaking order within a period of one week from the date of receipt of a certified copy of this order.”***
