Whereas, the Health and Medical Education Department, vide indent No. HD/Drug/24/2020 dated 25-09-2020 and No. HD/Drug/24/2020 dated 07.01.2021, vide indent No. ME/NG/83/2020 dated 08.03.2021, vide indent No. HD/Coord/64/2020 dated 25.09.2020, vide indent No. HD/Coord/63/2020 dated 25.09.2020, vide indent No. HD/ISM/62/2020 dated 25.09.2020 and No. HD/Coord/64/2020 dated 05.03.2021 and vide indent No. ME/NG/83/2020 dated 28.09.2020, among other posts, forwarded the requisition for making direct recruitment to the 65 posts under various items as per the following break up:

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 65 posts among other posts of Health and Medical Education Department vide Advertisement Notification No. 02 of 2021 dated 26.03.2021; and

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the Computer Based Test (CBT) for these posts in multiple sessions/slots w.e.f. 17.08.2021 to 25.08.2021; and

Whereas, on the basis of merit obtained by the candidates, the Document Verification was conducted in terms of Notice No. SSB/CoE/Health/2021/7598-7606 dated 09.11.2021, from 20.11.2021 to 04.12.2021, at Jammu and Srinagar by the DV Committees constituted vide Order No. 380-SSB of 2021 dated 17.11.2021 followed by Order No. 386-SSB of 2021 dated 18.11.2021 and Order No. 389-SSB of 2021 dated 18.11.2021. Separate DV committees for the left-out candidates were constituted vide Order No. 348-SSB of 2021 dated 30.11.2021; and

Whereas, the candidates figuring in the consideration zone for the above mentioned posts were allowed to indicate the order of preference for various posts/items through a link provided on the official website of the Board www.jkssb.nic.in from 17.11.2021 to 25.11.2021, vide Notice No SSB/CoE/Health/2021/7695-7704 dated 17.11.2021, the date for which was extended upto 30.11.2021 vide Notice No SSB/COE/Health/2021/7958-67 dated 25.11.2021; and

Whereas, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No.344-SSB of 2021 dated 29.11.2021, that was superseded by the constitution of a committee vide Order No.277-SSB of 2022 dated 8.10.2022; and

Whereas, the matter was in the Hon'ble Central Administrative Tribunal against the said selection process in the case of Hilal Ahmad Bhat and others vs UT of J&K and others case, wherein, the Hon'ble CAT Srinagar clubbed TA No. 5646/2021 and TA No. 221/2021, that were disposed of by way of a common order on 15.11.2022 with the following directions:

" In view of the above discussion, it is clear that the applicants are governed by the rules of 2009 which clearly state that the engagement of applicants was on academic arrangement basis for a period of one-year extendable upto a maximum of six years or till selection is made in accordance with the recruitment rules. The applicants had also executed an agreement/contract with the respondents that they will not claim for regularization of their services, The respondents were well within their jurisdiction and competence to issue the advertisement notification 02 of 2021 dated 26.03.2021.

With these observations, TA 5646/2021 and TA 221/2021 along with all the MAs are dismissed. All the interim orders stand vacated. The respondents are at liberty to proceed further to complete the process of selection and appointment of candidates as per advertisement notification No 02 of 2021 dated 26.03.2021. No order as to costs"

Whereas, the petitioners, aggrieved of the final order of Hon'ble CAT Srinagar, mentioned above, approached the Hon'ble High Court of J&K and Ladakh, wherein the **Hon'ble High Court of Jammu & Kashmir and Ladakh** at Srinagar in WP(C) No. 2682/2022, while pronouncing its Judgement on 31.01.2023, upheld the decision of **the Hon'ble Central Administrative Tribunal, Srinagar Bench** and maintained that:

"In view of the above and having regard to clear position of law enunciated by the Supreme Court in Uma Devi (3), we fully concur with the view taken by the CAT, Srinagar Bench. We find no merit in these petitions and the same are, accordingly, dismissed. The interim directions, if any, shall stand vacated. The respondents are free to conclude the selection process initiated vide advertisement Notice No. 02 of 2021"

Whereas, after receiving the aforementioned directions from the Hon'ble High Court of Jammu & Kashmir and Ladakh on 31.01.2023, the selection committee started preparing the provisional selection list, by following the principle of *Merit-cum-Preference*; and

Whereas, as per the Indent, the eligibility requirement for item Nos. 167, 175 and 218 is (was) "10+2 with science or above qualification with minimum two years Diploma in X - ray Assistant Course or having Degree in X-ray Technology/Radiography Course from any recognized Institution/State Medical Faculty/J&K Paramedical Council." and while making selections to the aforementioned posts, the Selection committee came across a wide range of Degrees, with varied nomenclatures, possessed by the candidates and the same had also been pointed out by the DV committee at the time of Document verification. The different Degrees which the candidates were in possession of, are listed as under:

1. B.Sc. Radiology and Imaging Technology
2. B.Sc. Radiation and Imaging Technology
3. B.Sc. Medical Radio-Imaging Technology
4. B.Sc. Medical Imaging Technology
5. B.Voc. Medical Imaging Technology

7. B.Sc. Radiological Imaging Techniques

13. B.Sc. (Paramedical) Medical Radio Diagnosis and Imaging Tech.

Whereas, the matter was taken up with the indenting department vide letter no: **JKSSB/Sel/Secy/2023/561-66 dated 03.05.2023**, who vide letter No. **ME-NG/261/2023-02 dated 24.08.2023**, in consultation and agreement with J&K Paramedical council has clarified that:

"...all the categories have been recognized by J&K Paramedical Council for registration except category mentioned at Sr. No. 5, viz B. Voc. in Medical Imaging Technology. Therefore, it would not be out of context to submit that all the categories can be considered eligible for the said posts in the referred advertisement, except the Programme of (B. Voc. Medical Imaging Technology) which would be submitted after due deliberation & suggestions of J&K Paramedical Council under relevant norms. It is therefore intimated that all the degrees with different nomenclatures can be considered eligible for the posts advertised relevant to Radiology and Imaging Technology, etc., which have been advertised vide notification No. 02 of 2021, dated 26.03.2021, in the Item No. 167, 175, 218."

Whereas, in OA 1445/2021 (RECRUITMENT) (Angrez Singh Vs Health and Medical Education Department), pertaining to selections to the post of E.C.G. Technicians (Item 165 in the current advertisement, i.e., 02 of 2021), the Hon'ble CAT, Jammu Bench, in its order dated 22.09.2021 has maintained that:

"...the respondent may go on with the selection process, however, they will not finalize the selection process till the next date of hearing before the Bench."

Whereas, keeping in view the afore-stated facts, clarification from H and ME Department and the directions of the Hon'ble CAT, Jammu Bench, in the OA mentioned above, the Provisional Selection list so prepared, by following the principle of *Merit-cum-Preference*, was approved by the Board in its 235th Board Meeting held on 05th September, 2023, which was subsequently notified vide Notification No. SSB/Sel/Secy/2023/869-878 dated 15.09.2023.

Whereas, the candidates aggrieved with the Provisional selection were asked to represent within 3 days from the date of the aforementioned notification through the email address **healthhelpdeskjkssb2023@gmail.com**; the representations so received have been examined in light of the rules on the subject; and

Whereas, after the notification of the Provisional Selection List, in another clarification tendered by the Department of Health and Medical Education in response to the letter No. JKSSB-SD0SECY(UT)/1/2023(E-7099079) Dated 11.10.2023, it has been clarified that:

“...Point No - 2 :- Regarding validity of two years advanced diploma in Medical Imaging & Technology.

In this regard, it is submitted that the eligibility criteria for Diploma in X-Ray Assistant course as offered by J&K Paramedical Council is 10+2 with Science and the duration of course is 2 years. As such the diploma in Medical Imaging & Technology as a part of B.Voc in Medical Imaging technology can be considered if acquired through a recognized institution/University, recognized by UGC and if otherwise eligible (i.e., 10+2 with Science with 2 years duration)...”

Whereas, consequent upon the receipt of the aforesaid clarification, the recommendation of one candidate, namely Ms. Snowber Mehraj (2913 – KMR), which was earlier kept withheld, has been released; and

Whereas, the Hon'ble Central Administrative Tribunal Jammu Bench, in the O.A./1445/2021 (JAMMU), titled Angrez Singh vs D/O Health and Medical Education UT of Jammu & Kashmir, mentioned above, in its order dated 15.12.2023, while upholding the verdict of the Hon'ble Supreme Court of India has vacated the stay granted earlier by directing that:

“...In order to take this matter forward, we have taken into account the fact that the Hon'ble Apex Court has already protected the service rights of the applicants, which the respondents should also adhere to. We vacate the stay granted by this Tribunal vide order dated 22.09.2021 and direct the respondents to go ahead with the selection and appointment of private respondents No. 6 to 10 and other eligible candidates without affecting the service condition of the original applicants...”

Whereas, after considering the representations and in light of the clarifications provided by the indenting department and CAT order mentioned-above, the Board in its 253rd Board Meeting, approved the Final Selection List for the 60 posts under Item No. 165 (E.C.G. Technician, Divisional Cadre, Jammu), Item No. 167 (X-Ray Technician/Radiology Technologist/ Junior Radiology Technician/ Radiology Technician/CT Scan Technician, Divisional Cadre, Jammu), Item No. 175 (X-Ray Assistant, Divisional Cadre, Jammu), Item No. 218 (X-Ray Assistant, Divisional Cadre, Kashmir), Item No. 220 (Dark Room Assistant, Divisional Cadre, Kashmir), Item No. 320 (Jr. X-Ray Tech., District Cadre, Jammu), Item No. 336 (Jr. X-Ray Tech., District Cadre, Udhampur), Item No. 344 (Jr. X-Ray Tech., District Cadre, Reasi), Item No. 364 (Jr. X-Ray Tech., District Cadre, Ramban), Item No. 390 (Jr. X-Ray Technician, District Cadre, Ganderbal) and Item No. 411 (X-Ray Assistant, Divisional Cadre, Jammu), of Health and Medical Education Department, Advertisement No. 02 of 2021 dated 26.03.2021.
