Subject: Directions of the Hon'ble Central Administrative Tribunal, Jammu in OA titled Ranjeet Singh and Ors Vs Union Territory of Jammu and Kashmir and Ors-Opportunity for being heard thereof.

NOTICE

Whereas vide Notification No.JKSSB-PLAN/25/2022-03 dated 25.11.2022, the Jammu & Kashmir Services Selection Board (JKSSB) notified the Provisional Selection List of the candidates for the posts of Junior Assistant/Cashier/Clerk/Store Attendant/Cadrex Clerk/Computer-cum-Junior Assistant/Welfare Organizer of various Departments for UT Cadre, Divisional Cadres and various District Cadres, advertised vide Notification No. 04 dated 16.12.2020, No.05 dated 24.12.2020, No.06 dated 29.12.2020 & No.07 dated 31.12.2020 of 2020 & Notification No. 01 dated 03.02.2021, No.02 dated 26.03.2021 & 03 dated 04.06.2021 of 2021; and

Whereas, the above Notification *inter-alia* provided that the candidates may represent for any grievances/objections to the provisional list within seven days; and

Whereas, the representations received in the matter were examined and taking into consideration the issues raised by the candidates, the Selection Committee constituted for these posts observed that some changes in the Provisional List are imperative. The matter was, accordingly, placed in the Board for deliberations/decision, which in its 216th meeting held on 26.12.2022, deliberated the matter and approved the Notification of a Revised Provisional Selection List for these posts; and

Whereas, in supersession of Notification No. JKSSB-PLAN/25/2022-03 dated 25.11.2022, *the <u>Revised Provisional Selection List</u>* of the candidates selected (provisionally) for the aforementioned posts was notified vide Notification No.JKSSB-PLAN/25/2022-03 dated 30.12.2022; and

Whereas, some candidates, aggrieved of the above, approached the Hon'ble Central Administrative Tribunal, Jammu through the medium of OA titled Ranjeet Singh and Ors Vs Union Territory of Jammu and Kashmir and Ors seeking following relief:

> "Stay the operation of Notification No.JKSSB-PLAN/25/2022-03 dated 30.12.2022 till the final disposal of the above titled OA.

Or

Alternatively, appropriate directions be issued to the respondents No.2 & 3 to accord consideration to the different representations (Annexure-IV) by passing a speaking and reasoned order and also afford a reasonable opportunity of being heard to the applicants and the outcome of the representation so filed may be communicated to the applicants and till then, it is prayed that appropriate directions be issued to the respondents not to finalize the selection process on the basis of the second provisional list dated 30.12.2022..."

Whereas, the Hon'ble Central Administrative, Jammu, vide its Order dated 16.01.2023, disposed of the above titled OA with the following directions:

"In view of the above, the Original Application is disposed of with a direction to Jammu & Kashmir Service Selection Board to publish the final selection list after considering the objections submitted by the aggrieved candidates. Needless to observe that in terms of undertaking given by Mr. Sudesh Magotra, learned Additional Advocate General, the aggrieved candidates shall also be afforded the opportunity of hearing before taking any decision over their objections."

Whereas, some petitioners, have submitted objections on the email address *jkssbjaselection2022@gmail.com,* which are under examination in the Board. However, in deference to the directions of the Hon'ble CAT, Jammu, it has been decided that the aggrieved candidates (petitioners in the aforementioned

OA), shall be afforded an opportunity of being heard also before taking any final decision on their objections.

Now therefore, the candidates as figuring in **Annexure-A** to this Notice, are hereby informed to attend the office of Secretary, J&K Services Selection Board, at Hema Complex, Sector-3, Channi Himmat, Jammu on <u>15.02.2023 at 11 AM</u> to present their case/objections to the Revised Provisional Selection List for the aforementioned posts notified vide No.JKSSB-PLAN/25/2022-03 dated 30.12.2022, beyond which no further opportunity of being heard shall be afforded and the decision on the objections shall be taken by the Board on merits.
