Subject: - Selection of the candidate for the post of 'Junior Assistant' (Civil Aviation Department), State Cadre vide Advertisement Notification No. 05 of 2015 dated 01.09.2015 under Item No. 171.


Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of Junior Assistant (Civil Aviation Department), State Cadre vide advertisement Notice No. 05 of 2015 dated 01.09.2015 under item No. 171 and recommended the same to the Indenting Department vide communication No. SSB/Secy/Sel/2017/7914-20 dated 31.08.2017 for further course of action and the selection of one candidate was kept blank/unfiled for want of certain clarification; and

2. Whereas, Mr. Rajan Khajuria, S/o Sh Raghbir Khajuria moved a representation, wherein, he stated that he has qualified the type test for the Advertised post and appeared in the interview also. After releasing of the final select list, his name did not figure in the select list. The applicant further states that as per the RTI response received from the Services Selection Board, it was found that his final merit was 62.2000, however, the candidate with lower merit has been selected; and


3. Whereas, Mr. Rajan Khajuria further submitted that he approached the then Chairman, JKSSB who advised the applicant to produce the document in support of his qualification to the Secretary, JKSSB; and

4. Whereas, vide JKSSB communication No. SSB/Sel/Secy/2018/10813-14 dated 25.10.2018, the Registrar, Sikim Manipal University of Health, Medical & Technological Science, Gangtok was requested to intimate the date of admission of candidate in BCA and date of completion of graduation and date of issuance of degree certificate; and

5. Whereas, in response to the said communication dated 25.10.2018, the Additional Registrar, Admission & Students Evaluation, SMU-DDE, Sikkim Manipal University, Gangtok vide letter No. SMU-DDE-VERI-6357 dated 28.11.2018 has clarified that Sh Rajan Khajuria bearing Roll No. 520759006 was the student of Sikkim Manipal University of Health, Medical & Technologies Sciences under the course Bachelors of Computer Applications (BCA) that commenced from January, 2005 (lateral Entry) and successfully completed the course in October, 2010. The degree certificate was issued under seal of University on 20<sup>th</sup> November, 2010 from its campus Gangok; and



6. Whereas, the Board vide communication No. SSB/Secy/Sel/20193285 dated 23.05.2019, also requested the Civil Aviation Department to convey whether the slot is still available with the Department or otherwise; and
7. Whereas, in response, the Civil Aviation Department vide their Office communication No. CMS/CAD/50/2014 dated 03.07.2019 has conveyed that no recommendation has been received so far against the blank slot under OM, which was kept unfilled by the SSB for want of certain clarification and is still vacant; and
8. Whereas, in the meantime, the Civil Aviation Department vide letter No. CMS/CAD/50/2014 dated 19.12.2019 has invited this office attention towards this office letter No. SSB/Secy/Sel/2019/3393 dated 09.10.2019, whereunder a list of two candidates as Junior Assistant (Civil Aviation Department) under Advertisement Notification No. 05 of 2015 dated 01.09.2015, item No. 171 has been recommended by the Service Selection Board and requested to convey as to whether the letter No. SSB/Secy/Sel/2019/3393 dated 09.10.2019 issued by J&K Services Selection Board is genuine/ authentic or otherwise as signature of the said letter seemed to be scanned one; and
9. Whereas, the main file was missing from the records and the dispatch number mentioned in the letter in question was not matching with the dispatch register of this office nor this office has issued any recommendations letter in favour of the candidates in question and vide this office letter No. SSB/Adm/37/2019/29 dated 09.01.2019, the Civil Aviation Department was informed that letter No. SSB/Secy/Sel/2019/3393 dated 09.10.2019 has not been issued by this Board and the same is fake, forged and scanned one and the recommendations in respect of both the candidates have not been cleared/released by this office and requested to treat the letter in question as null and void; and
10. Whereas, vide Order No. 71-SSB of 2020 dated 14-02-2020, issued under endorsement No. SSB/Adm/37/2020/1386-89 dated 14.02.2020, Mr. Ashwani Hans, Under Secretary, J&K Services selection Board was appointed as Inquiry Officer; and
11. Whereas, the Inquiry officer vide No. SSB/Enq/2020/2931-33 dated 30.04.2020 has submitted his enquiry report and recommended to lodge FIR immediately against the 02 candidates who were figuring in the fake selection list for forging, putting scanned signature of Secretary JKSSB on the letter forwarded to Civil Aviation department Civil Secretariat and to expose the names of official/officials involved, if any with them and Police may be asked to investigate further into the matter to find the truth behind the missing of original selection file of Junior Assistant (Civil Aviation Department) State cadre, 05 of 2015 under item no. 171; and
12. Whereas, the matter was placed in its 171<sup>st</sup> Board meeting and the same was discussed in the Board and was decided that to defer the case to reach a conclusion in view of the restriction on movement on account of extra circumstances prevailing due to Covid-19 Pandemic. It was further decided that in the meanwhile, efforts would be made






by the concerned to locate the important original selection file within two weeks as a matter of last opportunity. Further Controller of Examination/Secretary, JKSS will explore whether a shadow file can be constructed, to take the selection process to logical conclusion; and


13. Whereas, the matter was placed before the Board in its 173<sup>rd</sup> Board meeting for discussion/deliberation. The Board considered the matter and after evaluating all relevant aspects, observed that more than adequate time was given to the concerned officials for locating the missing file. Missing file could not be located and the concerned officials have continuously maintained to have no knowledge of the said file. Therefore, taking into account all relevant aspects, the Board decided to refer the matter of UT (Crime Branch) for further legal action as deemed fit and necessary in the facts and circumstances of the case. It was also decided in the said Board meeting that discreet verification of the documents (photocopies) available in the shadow file be conducted, Secretary, J&K Services Selection Board was directed to get the discreet verification done in a time bound and diligent manner; and

14. Whereas, vide this office letter No. SSB/Adm/37/2019/3521 dated 09.10.2020, the matter was taken up with the Registrar, Sikkim Manipal University of Health and Medical & Technological Sciences, Gangtok. In response, the Additional Registrar, Sikkim Manipal University, Admission & Students Evaluation, SMU -DE has stated that letter No. SMU/DDE/Bon/SC/01635/1097 dated 15.10.2015 is legitimate and is issued under the seal of Sikkim Manipal University; and

15. Whereas, vide this office communication No. SSB/Adm/37/2019/3411 dated 22.09.2019, the was taken up with the Inspector General of Police, Crime Branch, J&K, Srinagar that one Mr. Showket Ahmad Bhat S/o Ab. Ahad Bhat R/o Karimabad, Pulwama and Mr. Adil Mushtaq S/o Mushtaq Ahmad Mir R/o Pahoo, Pulwama are said to have arranged fake selection list after putting scanned signature of Secretary J&K Services Selection Board on the letter and forwarded it to Civil Aviation Department vide No. SSB/Secy/Sel/2019/3393 dated 09.10.2019, (copy enclosed). Further, the Original Selection File of Junior Assistant State Cadre, under Advertisement Notification No. 05 of 2015, item no. 171 is missing from the record and despite untiring efforts could not be traced. The matter was considered in the 173<sup>rd</sup> Meeting of the Board and after due deliberations, it was felt that the matter requires to be referred to the Union Territory Crime Branch for legal action, as is necessary in the facts and circumstances of the case and request to proceed in the matter for appropriate necessary action; and

16. Whereas, the Board again took up the matter with the Registrar, Sikkim Manipal University of Health, Medical & Technology Sciences, Gangtok vide letter No. SSB/Adm/37/2019/3521 dated 09.10.2020 regarding verification of Bonafide certificate in terms of Government Order No. 252-HE of 2012 dated 30.05.2012 of the candidate namely Shri Rajan Khajuria; and






17. Whereas, in response, Sikkim Manipal University vide letter No. DDE/Veri/02/1489 dated 26.10.2020, informed that the Bonafide certificate issued vide No. SMU/DDE/Bon/SC01635/1097 dated 15.10.2015 is genuine; and

18. Whereas, the case of the candidate was placed in the **177<sup>th</sup>** Board Meeting and it was decided to release the selection of the above said candidate on the basis of communication received from the Sikkim Manipal University.

Now, therefore, in view of the above position, the withheld selection of the candidate namely Shri Rajan Khajuria S/o Shri Raghbir Kumar Khajuria under OM category for the post of Junior Assistant (Civil Aviation Department), State Cadre pursuant to Advertisement Notice No. 05 of 2015 dated 01.-09.2015 under item No. 171 is released as per the details mentioned at "**Annexure-A**" to this order. The other terms and conditions already conveyed vide this office letter No. SSB/Secy/Sel/2017/7914-20 dated 31.08.2017 to the Civil Aviation Department will remain the same.
