Sir,

- Whereas, the Services Selection Board received indent/requisition from **Technical Education Department**. The Breakup of posts shown against each indent is given below:
- Whereas, against Indent No. **Edu/Tech/Phy/06/2007 Dated: 23.05.2008** Board advertised 18 posts (RBA=07, SC=05, ST=06) of "**Physical Education Teacher**", **District Cadre Poonch**, in pursuance to the advertisement notification 02 of 2013 (Item No. **223**). The Select list for the said item is hereby enclosed as (**Annexure "A"**).
- Whereas, against Indent No. **Edu/Tech/Phy/06/2007-II Dated: 11.06.2013** Board advertised 51 posts (OM=35, RBA=05, SC=04, ST=05, ALC=01, OSC=01) of "**Physical Education Teacher**", **District Cadre Poonch**, in pursuance to the advertisement notification 09 of 2013 (Item No. **724**). The Select list for the said item is hereby enclosed as (**Annexure "B"**).
- Whereas, in response to the said advertisement notifications candidates having qualified the written test were shortlisted for interview in the ratio of 1:5 wherever applicable.
- Whereas, on the basis of points obtained in written test, weight-age determined in accordance with selection criteria and the interview awards, select list so framed on the basis of merit was approved by the Board.
- Whereas, the Services Selection Board had already forwarded selection list vide letter No. SSB/Secy/Sel/2016/3061-67 dated: 03.02.2016.
- Whereas, **the Hon'ble High Court, J&K, in SWP No. 603/2016, MP Nos. 4/2016 & 1/2016 titled Mohd. Akhlaq & Others v/s State of J&K and Others** vide order **dated 31.01.2017** has directed as under:

"In my opinion, section 04 of J&K Reservation Act, 2004 had to be applied to the Selection at hand those candidates belonging to the reserved categories, who had secured more marks than the open merit category candidates ought to have been shifted to the open merit category and consequent thereto candidates from the waiting list or beyond in their respective categories would consequently be pushed up in their respective categories".

"As a result of the above it would appear that two candidates in the RBA Category and four candidates in the ST Category, by virtue of having secured more merit than the open merit category candidates would have to be pushed up leading to creation of similar vacancies in their respective categories, which were required to be filled up from within the category in accordance with merit. To that extent, the select list would have to be redrawn. As a consequence of the redrawing of the select list, last six candidates whose name figured in the open merit category would have to be pushed out."

"It needs to be mentioned that respondent No.5 and 6 are stated to have applied for both the notifications, therefore, their names be also considered for notification No. 09 of 2013 for invoking section 4 of J&K Reservation Act, 2004. It would, however, remain open to the respondent No. 5 and 6 not to opt for appointment pursuant to Notification No. 09 of 2013. If they do so, then the vacancies on account of non joining of the said respondents pursuant to notification NO. 02 of 2013 would be filled up by the candidates next in the merit".

In addition to the above, Secretary J&K State Sports Council in pursuance to the observations made at Para-17 in the aforementioned Judgment in terms of communication No. SC/2353/7472 Dated.13.02.2017 has conveyed that the Sports Certificates furnished by respondent No.13 (Bashir Ahmad S/O Abdul Rashid, Intl S.NO.25, Roll NO.1311600320) and 14 (Ghulam Mohi ud Din S/O Amir Din, Intl S.NO.32 Roll NO.1311600468) have not been issued by recognized National Sports Federation viz Taekwondo Federation of India, as such the Certificates required no credit. In the back drop of the said communication the Additional Sports Points allotted to these two Candidates have been deducted.

"...Admittedly, common screening test as well as common interview was conducted by the Services Selection Board in respect of both the Notifications. Since, writ respondents 5 & 6 has applied under RBA Category in both the Notifications and have admittedly secured much higher marks than the last selected Candidates in the Open Merit Category in Second Notification Dated 21.06.2013, the writ court has rightly directed for reframing/redrawing the select lists thereby pushing up writ respondents 5 & 6 to the Open Merit Category, only if they opt for appointment pursuant to second Notification No. 09 of 2013 Dated 21.06.2013, and in such a situation the resultant vacancies were directed to be filled up, either from the waiting list of RBA category or in accordance with merit beyond that category. Since writ respondents 9,10,11 & 12 had admittedly applied only in respect to first Notification No.02 of 2013 Dated 16.06.2013 under ST Category, they cannot be directed to be pushed up to the Open Merit Category in respect to second Notification NO.09 of 2013 Dated 21.06.2013, even if they have secured more marks than the last selected candidates in the Open Merit Category in respect of second Notification Dated 21.06.2013, for the simple reason that they never applied pursuant to second Notification nor the provisions of J&K Reservation Act say so ..."

- Whereas, in addition to the above, Secretary Sports Council vide communication NO.SC/2353/7472,Dated 13.02.2017 has conveyed that the Sports Certificates furnished by respondent NO.13 (Bashir Ahmad) & 14 (Gh. Mohi-ud-Din) have not been issued by recognized National Sports Federation, as such require no merit.
- Whereas, on the direction of Hon'ble High Court a revised selection list has been prepared after doing the needful.
- Whereas, in supersession of letter No. SSB/Secy/Sel/2016/3061-67 dated: 03.02.2016 where under the selection list was forwarded, the revised selection list for the post of **Physical Education Teacher, District Cadre Poonch**, Item No. **223** (02 of 2013) and Item No. **724** (09 of 2013) is framed and hereby enclosed as Annexure "A" and "B".
- Whereas, the revised select list shall be subject to outcome of any writ petition(s), if any, pending in any court of the competent jurisdiction.
- **That the Board is devoid of any fool proof mechanism/resources to verify the recognition status/genuineness of qualification/category certificates/ permanent resident certificate/ Domicile Resident of concerned District for a period not less than 15 years except Schedule Caste Category.**

- Therefore, the indenting department shall have to verify position confidentially from the concerned Universities/ Institutions/departments.
- You are further requested that in case any certificate/document during the course of verification turns out to be fake/fictitious, the Board may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
