Subject:- Selection list of the candidates for the post of Junior Assistant (Cooperative Department) District Cadre, Poonch, Advertisement Notice No. 03 of 2012 Item No. 385, dated 13.02.2015.

Whereas, the J&K Services Selection Board forwarded a select list of the candidates for the post of "Junior Assistant" (Cooperative Department), District Cadre, Poonch, vide No. SSB/Sel./Secy/2015/2076-81 dated 13.02.2015 to the Indenting Department in pursuance of advertisement Notice No. 03 of 2012 item No. 385 for further course of action;
