## Notice

**Subject:-** Compilation of selection list for the item Nos. 011, 012 (01 of 2013), 292 , 296(01 of 2011), 22(01 of 2015), 244, 287 (05 of 2015)- Submission of preference thereof.

1) Whereas, the J&K Services Selection Board advertised posts of Demanstrator Computer Engineering, Demanstrator OM & Computer Application Engineering, Vocational Instructor Mechanic Computer Harddware, Senior Laboratory Technician (Computer Engineering), Computer Operator; and

2) Whereas, the Board conducted the common written Test for the above said posts/Notifications; and

3) Whereas, as per scores obtained in common written test, the short listing of the candidates was formulated by the SSB and subsequently notified ; and

4) Whereas, it has emerged that most of the candidates, on the basis of their score obtained in the written examination, have been shortlisted in multiple items/notifications; and

5) Whereas, in order to avoid repetition of candidates in the selection lists for the posts of Demanstrator Computer Engineering, Demanstrator OM & Computer Application Engineering, Computer Operator, Vocational Instructor Mechanic Computer Hardware, Senior Laboratory Technician (Computer Engineering), it is imperative to seek the preferences/options from the candidates who have been shortlisted for more than one item Nos.

Now, therefore in the back drop of aforementioned facts/situation the candidates who have been shortlisted for more than one item are requested to submit their preference for various items/notifications as per format given below in the Divisional Office of the J&K SSB, Palloura Jammu ( Jammu based candidates) and Divisional Office of J&K SSB, Parraypora, Srinagar( Kashmir based candidates), upto 16<sup>th</sup> of October-2017. However, while exercising the preference, the following points shall be born in mind:-

1. That the Board will consider the preferences/options only if he/she finds place within the selection zone in more than one item No.
2. The preferences/options of any candidate shall be operated strictly in order of the merit & there shall be no compromise in the merit under any condition.
