Subject:- SWP No. 1711/2016 titled Akshaya Thakur Vs State and ors.

- 1) Whereas, the JK Services Selection Board vide advertisement Notification No. 02 of 2014 dated 30.12.2014 invited applications from eligible candidates for the post of JE. Civil, State cadre under item No. 134.
- 2) Whereas, petitioner applied under RBA category participating in the selection process conducted by the Board and got selected under RBA category at S.No 8 but his recommendation was kept withheld subject to the production of valid Category Certificate and in the remarks column it was reflected that **recommendation withheld and is subject to production of valid category certificate.**
- 3) Whereas, petitioner approached before the Hon'ble High Court through the medium of SWP No. 1711/2016 seeking directions from the Hon'ble High Court against respondent no 2 to entertain and accord the cognizance to the RBA certificate dated 28/05/2016 and forward the recommendations of selection of the petitioner to the concerned Department (PWD/R&B) forthwith etc.
- 4) Whereas, in MP NO 1/2016 filed in SWP No 1711/2016, the Hon'ble High Court vide order dated 19/08/2016 directed as under:

*"In the meantime, Subject to objections and till next date before the Bench, one post of Junior Engineer (Civil) under RBA category notified vide advertisement notification no. 02 of 2014 dated 30/12/2014 shall not be filled up".*


- 5) Whereas, the Hon'ble High Court has finally disposed of SWP No 1711/2016 vide judgement dated 25/05/2017. The operative part of the judgement dated 25/05/2017 is reproduced as under:

*"This petition is, accordingly, disposed of with a direction that the respondents shall pass appropriate orders in accordance with the rules within a period of three weeks after a copy of this order is made available to the respondent Board by the petitioner."*

- 6) Whereas, the case of the petitioner was examined and it is reflected in the records that the petitioner had submitted his RBA certificate before the Board and his status as RBA is not disputed. However, his recommendation was kept withheld for production of valid category certificate. Same has been furnished by the petitioner as such there remains no reason for not releasing the recommendation of the petitioner who has made merit under RBA category and is figuring at S.No 8 on the basis of merit obtained by the petitioner during selection process conducted by the Board.

Now, therefore in compliance to the judgement dated 25/05/2017 of the Hon'ble High Court passed in SWP No 1711/2016 coupled with the facts of the

case, the claim of the petitioner is found on merits. Hence, recommendation of the petitioner namely Akshaya Thakur S/O Satpal Thakur R/O Basooli Kathua figuring at S. No 8 in the select list under RBA category advertised vide notice no 02 of 2014 dated 30/12/2014 under item No 134 is released to the post of JE Civil State cadre. However, the other terms and conditions shall remain same as already conveyed in the said list.
