Subject:- SWP No. 203/2015 titled Kounsar Maqbool Vs State and ors.

Order No. ~~64~~ SSB of 2017

Dated:- 10.11.2017

- 1) Whereas, the JK Services Selection Board vide advertisement Notification No. 04 of 2013 invited applications from eligible candidates for the post of FMPHW/ANM, district cadre Baramulla under item No. 302; and
- 2) Whereas, petitioner participated in the selection process conducted by the Board and qualified the written test but could not appear in the interview on the date scheduled by the Board; and
- 3) Whereas, petitioner approached the Hon'ble High Court through the medium of SWP No. 203/2015 seeking directions from the Hon'ble High Court against respondents in nature of prohibition/prohibiting respondents from completing the process of selection/ appointment to the post of FMPHW for district cadre Baramulla on the basis of interview conducted on 2/2/2015 in exclusion of petitioner and commanding the respondents more particularly the respondent no 2 and 3 to conduct the interview of the petitioner for the said post on the basis of shortlist prepared by the Board, etc; and
- 4) Whereas, In IA No. 297/2015, filed in SWP No 203 of 2015, the Hon'ble High Court vide order dated 12/2/15 was pleased to direct as under:

*"Notice in CMP as well.*

*In the meantime, respondents to allow petitioner to appear in the interview at her own risk and responsibility without any rights flowing in his favour out of mere participation in selection process/ interview. This order shall be subject to objections of other-side and not to be taken as one determining petitioner's eligibility for advertised post. List on 19<sup>th</sup> March 2015."*

- 5) Whereas, in compliance to the directions of the Hon'ble High Court dated 12/2/2015 interview of the petitioner has been conducted by the Board and in the selection list issued by the Board and in the petitioners' remark column it was reflected "**Earlier absent, interviewed as per Court direction (SWP No. 203/2015);** and
- 6) Whereas, during the examination of the records, it transpires that 21 posts were advertised under OM category and only selection of 11 candidates has been framed and a slot was kept unfilled under OM category. Moreover, 09 posts remained vacant due to non-availability of eligible candidates; and

7) Whereas, in the selection process, the petitioner on the basis of her merit is figuring at S.No 6 under OM Category and there seems no justification for not releasing the recommendation of the petitioner after verifying and scrutinizing the merit of the petitioner.

Now, therefore in view of the facts stated herein above read with the rules and procedure adopted for the determination of the merit of the selectees for the post of FMPHW/ANM at the relevant point of time, petitioner's (Shri. Kounsar Maqbool D/O Maqbool Hussain Dar R/O Nooripora Pattan Tehsil Pattan District Baramulla) recommendation to the post of FMPHW/ANM, advertised vide notification no 04 of 2013, district cadre Baramulla under item No. 302 is hereby released and shall figure at S.No 6 under OM category in the original selection list issued by the Board. However, the other terms and conditions shall remain same as already conveyed in the said list.
