Sub:- Select list of candidates under SRO 202 dated 30.06.2015 for the post of "**Works Supervisor (Civil)**" Public Works (R&B Department), Divisional Cadre Kashmir in pursuance to advertisement notification No. 05 of 2015 dated 01.09.2015 under item No. 228.

1/ Whereas, the J&K Services Selection Board issued the select list of the candidates for the post of "**Works Supervisor (Civil)**" Public Works (R&B Department), Divisional Cadre Kashmir in pursuance to advertisement notification No. 05 of 2015 dated 01.09.2015 under item No. 228 and recommended the said select list to Public Works (R&B Department) vide this office letter No. SSB/Secy/Sel/2017/1628-34 dated 03.02.2017 for favour of further course of action; and

2/ Whereas, amongst others the recommendation of the candidate namely **Mohd Iqbal Dar S/o Mohd Shaban Dar figuring at S.No.01 under RBA category** was kept withheld and is subject to production of STC certificate and recognition of Institute; and

3/ Whereas, the said candidate has failed to submit his documents for release of his recommendation for the post of "**Works Supervisor (Civil)**" Public Works (R&B Department), Divisional Cadre Kashmir in pursuance to advertisement notification No. 05 of 2015 dated 01.09.2015 under item No. 228; and

4/ Whereas, the candidate did not submit the requisite documents for release of his recommendation, however he submitted an undertaking in the shape of Affidavit duly attested by **2<sup>nd</sup> Additional Munsiff** Judicial Magistrate Ist Class, Srinagar mentioning therein that the Deponent has been selected for the post of "**Works Supervisor (Civil)**" Public Works (R&B Department), Divisional Cadre Kashmir in pursuance to advertisement notification No. 05 of 2015 dated 01.09.2015 under item No. 228 at S.No.01 under RBA category is not willing to join the said post.

Now therefore, in view of the aforementioned circumstances, the withheld selection of the candidate **Mohd Iqbal Dar S/o Mohd Shaban Dar figuring at S.No.01 under RBA category** for the post of "**Works Supervisor (Civil)**" Public Works (R&B Department), Divisional Cadre Kashmir in pursuance to advertisement notification No. 05 of 2015 dated 01.09.2015 under item No. 228 is **cancelled abinitio**. Consequently the candidate namely **Javid Ahmad Bhat S/o Mohd Yousuf Bhat** earlier placed in waiting list at S.No.01 under RBA category vide this office order No. 273-SSB of 2017 dated 02.08.2017 issued under endorsement No. SSB/ Sel/ Secy/ 53/ 017/ 6619-21 dated 02.08.2017 shall now enter into the selection zone at S.No.01 under RBA category for the above said post.
