Subject:- Cancellation of Interview (*ab-intio*) held on 16.08.2017 for the post of Block Investigator (Industries & Commerce Department) Division Cadre Jammu advertised vide Notification No. 06 of 2013, Item No. 351.

1) **WHEREAS**, the Board had advertised 09 (Nine) posts (OM=04, RBA=02, SC=01, ST=01 & ALC=01) of Block Investigator (Industries & Commerce Department)-Division Cadre Jammu vide advertisement Notification No.: 06 of 2013 dated 10-05-2013, Item No. 351; **and**

2) **WHEREAS**, among other items the Board as per the notified schedule conducted written test for the advertised post on 23-06-2017. After conducting the written examination successfully, the Board shortlisted thirty candidates as per the merit for next stage, i.e., Viva voce; **and**

3) **WHEREAS**, the Board published the Interview Schedule for the shortlisted candidates and same was held on 16-08-2017 at Central Office (camp), SSB, Sehkari Bhawan, Rail Head Complex, Jammu. The Interview Committee in this regard was constituted vide Order No. 298-SSB of 2017 dated 10-08-2017; **and**

4) **WHEREAS**, after conclusion of the Interview, as per the procedure, the award rolls in sealed envelopes were handed over by the Convener of the interview committee to the Secretary, JKSSB and, after proper receipt, were handed over to the Secrecy Division for preparation of Selection List for the said item; **and**

5) **WHEREAS**, while framing the results, it was found that the awards had some over-writings in marks awarded to some of the candidates (vis-à-vis marks details given in numerals and words) and which were not attested by the concerned members. The issue was immediately brought to the notice of Secretary and Ld. Chairman, JKSSB; **and**

6) **WHEREAS**, the Ld. Chairman, desired the matter to be deliberated in the Board Meeting; **and**

7) **WHEREAS**, the matter after approval of Ld. Chairman was placed before the Board during meeting held on 29th & 30th November, 2017 and it has been decided that the Interviews held on 16-08-2017 for the post of Block Investigator

(Industries and Commerce Department) Division Cadre Jammu, advertised vide Notification No. 06 of 2013, Item No. 351, be treated as cancelled /void ab-initio and the interviews be conducted de-novo, for which schedule shall be published separately; **and**

Now, therefore, in view of the above, the interviews conducted on 16-08-2017 for the post of Block Investigator (Industries and Commerce Department) Division Cadre Jammu advertised vide Notification No. 06 of 2013, Item No. 351 are hereby cancelled as void ab-initio and the fresh interviews will be held for the said item, for which schedule will be published separately.
