Subject:- Select list of candidates under SRO 202 dated 30.06.2015 for the post of "Junior Pharmacist" (Health and Medical Education Department) Divisional Cadre Jammu, District Cadre Jammu, Kathua and Rajouri in pursuance to Advertisement Notification No. 06 of 2015 under item No. 502, 522 and 581.

- 1) Whereas, the J&K Services Selection Board has issued the selection list of the candidates for the post of "Junior Pharmacist" (Health & Medical Education Department), District Cadre, Jammu/Rajouri/Kathua pursuant to Advertisement Notification No. 06 of 2015, Item No. 502, 581, 522 and recommended the same to the intending department vide this Office letter No. SSB/Secy./Sel./2016/18500-506 dated 30.06.2016 for further course of action; and
- 2) Whereas, the selection of some of the candidates kept blank owing to the fact that the candidates who have made the grade for selection having degree in "B.Pharmacy".
- 3) Whereas, the matter with regard to clarification regarding consideration of "B. Pharmacy" was taken up with Health & Medical Education Department conveyed vide letter No. letter No. HD/NG/190/2017 dated 27.09.2017 and letter No. AHJ/2015/2939-40 dated 21.11.2015 conveyed us as:-

"As per Government Order No. 26-HME of 2006 dated 19.01.2016, the minimum qualification for the post of Junior Pharmacist is 10+2 or above with Diploma in Medical Assistants/Pharmacist training course from recognized institute. Hence, the candidates who possess either of the qualification are eligible. Further, B. Pharmacy is a higher qualification which can be considered only if the candidate possess minimum prescribed qualification".

4) Where as a notice vide No. SSB/Secy/Sel./2017/130031-37 dated 11.12.2017 issued to (05) candidates having B. Pharmacy Degree for submission of required documents. However, all these candidates failed to submit the requisite documents.

5) In the backdrop of the situation enumerated here in above, the blank slot at Sr No. 01/RBA/502, 06/OM/502, 02/OM/581, 04/OM/522, 05/OM/522, for the above said post is hereby cancelled abinitio. Consequently, the following position emerges.

Item No. 502 (06 of 2015)


The candidate namely Lokeshwar Sharma S/o Sh. Subash Chander Sharma earlier figuring at Sr. No. 01/OM/502 and Rakesh Kumar S/o Dharam Paul earlier figuring at Sr. No. 01/RBA/502 under wait list now enters in the selection zone and now figure at 13/OM/502 & 04/RBA/502 respectively. Further, candidate earlier figuring at Sr. No. 13/OM/502 will now be treated at Sr. No. 12/OM/502 and candidate earlier figuring at 04/RBA/502 will now be treated on Sr. No. 03/RBA/502 and so on

Item No. 522 (06 of 2015)

The candidate namely Nisha Sharma D/o Ram Paul Sharma R/o Maila Hiranagar, Kathua earlier figuring at 01/OM/522 and candidate Manorma D/o Prem Chand Dharmkote Bilawar, Kathua earlier figuring at Sr. No. 02/OM/522 under wait list now enters in the selection zone and now figure at Sr. No. 15/OM/522 and Sr. No. 16/OM/522 respectively. Further, candidate earlier figuring at Sr. No. 15/OM/522 enters at Sr. No. 14/OM/522 and candidate earlier figuring at Sr. No. 16/OM/522 will now at 15/OM/522 and so on.

Item No. 581 (06 of 2015)

The candidate namely Khaliq Anjum S/o Ghulam Ahmed R/o Shadra Shrief Thannamandi, Rajouri earlier figuring at Sr. No. 01/OM/581 under wait list now enters in the selection zone at Sr. No. 04/OM/581. Further, the candidate earlier figure at Sr. No. 04/OM/581 will now be figured at Sr. No. 03/OM/581 and so on.
