1/ Whereas, the J&K Services Selection Board forwarded a select list of candidates for the post of Warper-cum-Winder , Distt. cadre, Kathua, vide this office letter No. SSB/Sel/Secy/2017/4504-10 dated 26.4.2017 to the Industries and Commerce Department in pursuance of Advertisement Notification No. 03 of 2012, item No. 353;

2/ Whereas, the selection of the candidates namely Deshwer Sharma S/o Pritam Chand Sharma, figuring at S. No. 01 under OM category was kept withheld for want of relevant documents; and

3/ Whereas, the candidate was informed vide Notice issued vide No.SSB/Sel/Secy/2017/13115-18 dated 13.12.2017, whereby he was asked to produce the relevant documents/ testimonials within 05 days from the date of issuance of the subject notice; and

4/ Whereas, the said candidate has failed to submit the requisite documents. However, instead, he has submitted an affidavit attested by the Sub Judge Special Mobile Magistrate Kathua, mentioning that deponent is already working /serving Head Weaver and not interested to join for the post of Warper-cum-Winder , Distt. cadre, Kathua.

5/ Therefore, in view of the aforementioned position/facts, the selection of Deshwer Sharma S/o Pritam Chand Sharma, figuring at S. No. 01 under OM category item No. 353 (03 of 2012), for the post of Warper-cum-Winder , Distt. cadre, Kathua. in Department of Industries & Commerce, is hereby revoked. Consequently, the candidate namely Anil Kumar Sharma S/o Madan Lal Sharma, figuring at S. No. 01/OM(waiting list) shall now enter in the selection zone at S. No. 01/OM.
