Subject:- Provisional Shortlist for Counselling and document verification of candidates as per merit acquired in written test for Item No 020 (01 of 2017) and 036 (01 of 2017) which are in the Domain of Specific – Jr Nurse and the CBT was held on 21st December 2017-regarding.

1. Whereas the JKSSB conducted Computer Based written test for the subject posts on **21st December 2017**; and
1. Whereas, the appearance of the candidates in the written examination was purely provisional as the documents verification was still pending;
2. Whereas, the candidates figuring in Annexure “A” to this notice have now been shortlisted for document verification, on the basis of the merit acquired by them in the Written Test. It may be noted that candidates called for document verification are in excess of actual number of posts and as such no candidate figuring in the enclosed list should lay any claim to his/her inclusion in the final Selection list simply on the ground of being figuring herein; and

Whereas the candidates figuring in this provisional list are required to appear for counselling and document verification on **21st or 22nd February 2018 (any of the two days)** at **Central Office, J&K Services Selection Board, Sehkar Bhawan, Panama Chowk Rail Head Complex Jammu (Jammu Based items) and Camp Office, J&K Services Selection Board, Zum Zum Buidling Rambagh Srinagar, (Kashmir Based items) at 10.30 A.M.**

In case, a candidate fails to produce **Print out of his/her Online Application Form, original documents/certificates/Bonafide** etc., on the day of counselling or if he/she remains absent, the next candidate in order of merit will be recommended without any further opportunity to appear before the document verification committee as the Board cannot keep the selection process perpetually open. **Any such candidate who remains absent or fails to produce his/her documents will be declared “disqualified with reasons recorded by the Members of the verification committee”.**
5. The final selection list shall be issued only after the candidates are found confirmed as per Biometric cross verification and having fulfilled prescribed qualification/eligibility as per the Advertisement/Recruitment rules. **It is once again re-iterated that any candidate not appearing with his/her Online Application form will be disqualified.**
