- Against indent No. Rev/NG/72/06 Dated: 14.02.2008 Board advertised 07 posts (OM=03, RBA=02, SC=01, ST=01) of "Junior Assistant", District Cadre Poonch, in pursuance to the advertisement notification 02 of 2011 (Item No. 932). Therefore, the indenting department shall have to verify position confidentially from the concerned Universities/ Institutions/departments.
- You are further requested that in case any certificate/document during the course of verification turns out to be fake/fictitious, the Board may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
