1. Whereas, the Services Selection Board vide notification no. 05 of 2013 under Item No. 497 invited applications for eligible candidates for the post of Teacher in respect to District Cadre Ramban. Breakup of the posts advertised is given as under: and ;


2. Whereas, petitioner applied for the post of Teacher under ST category and participated in the selection process conducted by the Board in respect to the post of Teachers in terms of notification no. 05 of 2013.
3. Whereas, in the final selection list issued by the Board name of the petitioner figured at S. No. 9 under ST category in the selection list. However against her remarks column it reflected that "**recommendation withheld and is subject to production of Bonafide certificate regarding PG**".
3. Whereas, petitioner approached to the Hon'ble court through the medium of SWP No. 3318/2015 and sought directions from the Hon'ble High Court that the respondents, be commanded to issue appointment order in favour of the petitioners in terms of advertisement notification No.05 of 2013 as General line Teacher District Cadre Ramban; and further consider the degree of Graduation(BCA) obtained from Makhanlal Chaturvedi National University as valid degree for appointment to the post of Teacher District Cadre Ramban; and
4. Whereas, the Hon'ble High Court vide judgment dated 23.12.2015 has been pleased to disposed of writ petition No.3318/15. The operative part of the judgment dated.23-12-2015 is reproduced as under:-

**"In view of the matter, the writ petition is disposed of with a direction to the respondents to accord consideration to the case of the petitioner for appointment after examining the PG certificate as is stated to have been produced by the petitioner and received by them. The result of the consideration shall be conveyed to the petitioner within four weeks from the date copy of this order is made available to the respondents. Tight is**

**reserved to petitioner to re-agitate if thereafter any cause survives."**

5. Whereas, during this course the petitioner has already submitted Bonafide certificate of graduation required for the consideration to the post of Teacher same is found inconsonance with the rules which justifies her claim for the post of Teacher in District Cadre Ramban.

Now, therefore, in compliance to the judgment of Hon,ble High Court dated. 23-12-2016 passed in SWP No. 3318/2015 coupled with the facts stated herein above, recommendation in favour of the petitioner namely Shazia Bano D/o Shad Ali R/O Chanderkote, Tehsil & District Ramban figuring at S.No.09/ST for the post of **Teacher.**,(Education Department) advertised vide Notification No. **05 of 2013, in Item No. 497,** is hereby released. However, the other terms and conditions as conveyed in the main selection list shall remain the same.
