1) Whereas, the Services Selection Board forwarded select list of candidates for the post of Teacher (Education Department) in pursuance to Advertisement Notification No. 06 of 2013, under Item No. 620, (District Cadre Udhampur) to Education Department vide No.SSB/Secy/Sel/015/10956-63 Dated:-20-10-2015 for further course of action and ;

2) Whereas, Two slot were kept blank at S.NO. 13/RBA and 32/RBA, under item No. 620 (06 of 2013) for the following two candidates;


i) Soom Raj S/O Ram Chand figuring at S.No.13/RBA for want of certain clarification with regard to filled RBA in item No. 434 & 03(SC) in item No. 620 shortlisted as RBA(However, it was within cut off point of OM for item No.620).

ii) Shobha Rani D/O Subash Chander W/O Sat paul 32/RBA filled RBA in item No.434 & 03(SC) in item No. 620, shortlisted as RBA.(However, it was within cut off point of OM for item No. 620) ; and

3) Whereas, the case of the candidates were placed before the Board in its 126th Board meeting and the Board endorsed the non-eligibility of the candidates and selection of the both candidates to be cancelled ; and

Now therefore, in view of the above position it is construed that the above mentioned candidates (blank Slot) namely Soom Raj S/O Ram Chand figuring at S.No.13/RBA and Shobha Rani D/O Subash Chander W/O Sat paul 32/RBA for the post of Teacher District cadre Udhampur in pursuance to Advertisement Notification No. 06 of 2013, under Item No. 620 are hereby cancelled abinitio. The same slot be utilized in order of merit from the waiting list.

However, other terms and conditions already conveyed vide this office letter No. SSB/Secy/Sel/015/10956-63 Dated:-20-10-2015 shall remain the same.
