**Subject: - Cancellation of selection of the candidate for the post of "Junior Assistant" (Agriculture Production Department), State Cadre under Item No.171 (05 of 2015).**

1) Whereas, the J&K Services Selection Board issued selection list of candidates for the post of "Junior Assistant" State Cadre, advertised vide Notification No. 05 of 2015, Item No. 171 and recommended to the indenting department vide letter No.SSB/Secy/Sel/2017/7907-13 dated 31/08/2017 for further course of action.

2) Whereas, the recommendation of below mentioned candidate was kept withheld for want of certain documents; and

3) Whereas, the J&K Services Selection Board conducted a Special Drive vide No.SSB/Adm/2018/258-62 dated 03/01/2018 on 11<sup>th</sup> & 12<sup>th</sup> of January, 2018 to clear the pendency with regard to the withheld recommendations of the candidates; and


4) Whereas, among others the above said candidate was asked to present himself before the Board alongwith all the documents required to release his recommendation; and

5) Whereas, the above said candidate was failed to appear before the Board on 11<sup>th</sup> & 12<sup>th</sup> of January, 2018; and

6) Whereas, final notice was issued under endorsement No.SSB/Secy/Sel/2018/2667-69 dated 13/03/2018 giving last opportunity to the above said candidate to submit the relevant papers within 15 days otherwise he would forfeit his selection. No response has been received from the candidate till date.

Therefore, in view of the aforementioned circumstances, candidature of above mentioned candidate for the post of "Junior Assistant" State Cadre, advertised vide Notification No. 05 of 2015, Item No. 171 is hereby Cancelled/withdrawn abinitio. Consequently, the candidate who was earlier figuring at S.No.03 under OM category shall now become S.No.02 and 04 shall now become S.No.03 so on and so forth upto S.No.12 shall now become S.No.11. Subsequently, the candidate namely Tanveer Subhan S/o Mohd Subhan Yattoo who was earlier figuring in the combined waiting list shall now enter in the selection zone at S.No.12 under OM category whose particulars are given at Annexure 'A'.

However, other terms and conditions as already conveyed in the main selection list shall remain the same.
