

- 1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Draftsman Civil" (PHE/I&FC Department), Divisional Cadre Jammu under item No.046( 01 of 2013) and recommended the same to the intending department vide this office letter No. SSB/Secy/Sel/2016/8062-68 dated 05-04-2016 for further course of action; and
- 2) Whereas, the selection of the candidate namely Manish Kumar S/O Ashok Kumar, figuring at S.No. 03/OM/SC/046 was kept withheld and was subject to production of bonafide certificate/ validity and relevance of Draftsmanship course/recognition of institute; and
- 3) Whereas, the J&K Services Selection Board conducted a Special Drive vide No.SSB/Adm/2018/258-62 dated 03-01-2018 on 11<sup>th</sup> & 12<sup>th</sup> January, 2018 to clear the pendency with regard to the withheld recommendation of the candidates.
- 4) Whereas, among others the above said candidate was asked to present himself before the Board alongwith all the documents required to release his recommendation; and
- 5) Whereas, the above said candidate failed to appear before the Board on 11<sup>th</sup> and 12<sup>th</sup> of January, 2018.
- 6) Whereas, final notices were issued under endorsement No.SSB/Secy/Sel/2016/1464-66 dated. 26-02-2018 and No.SSB/Secy/Sel/2016/2667-69 dated. 13-03-2018 giving last opportunity to the above said candidate to submit the relevant papers within 10 days otherwise they would forfeit his selection. No response has been received from the candidate till date.

Now therefore, in view of the above position, the withheld selection of Manish Kumar S/O Ashok Kumar, figuring at S.No. 03/OM/SC/046 for the post of "Draftsman Civil" (PHE/I&FC Department), Divisional Cadre Jammu vide item No.046( 01 of 2013) is hereby cancelled as void ab-initio.
