Subject: - Cancellation of selection of the candidate for the post of "Junior Assistant" (Labour Employment Department), State Cadre under Item No.171 (05 of 2015).

1) Whereas, the J&K Services Selection Board issued selection list of candidates for the post of "Junior Assistant" State Cadre, advertised vide Notification No. 05 of 2015, Item No. 171 and recommended to the indenting department vide letter No.SSB/Secy/Sel/2017/7956-61 dated 31/08/2017 for further course of action.

2) Whereas, the recommendation of below mentioned candidate was kept withheld for want of certain documents; and

3) Whereas, the J&K Services Selection Board conducted a Special Drive vide No.SSB/Adm/2018/258-62 dated 03/01/2018 on 11th & 12th of January, 2018 to clear the pendency with regard to the withheld recommendations of the candidates; and


4) Whereas, among others the above said candidates were asked to present themselves before the Board alongwith all the documents required to release their recommendations; and

5) Whereas, the above said candidates were failed to appear before the Board on 11th & 12th of January, 2018; and

6) Whereas, final notice was issued under endorsement No.SSB/Secy/Sel/2018/2667-69 dated 13/03/2018 giving last opportunity to the above said candidates to submit the relevant papers within 15 days otherwise they would forfeit their selection. No response has been received from the candidates till date.

Therefore, in view of the aforementioned circumstances, candidature of above mentioned candidates for the post of "Junior Assistant" State Cadre, advertised vide Notification No. 05 of 2015, Item No. 171 is hereby Cancelled/withdrawn abinitio. Consequently, the candidate figuring at S.No.03 under OM category shall now become S.No.02 so on and so forth upto S.No.06 shall now become S.No.05 and the candidate earlier figuring at S.No.08 shall now figure at S.No.06 under OM category. Subsequently, the candidates namely Anirudh Charak S/o Darbar Singh Charak and Mandeep Singh S/o Tarlochan Singh who were earlier figuring in the combined waiting list shall now enter in the selection zone at S.No.07 and S.No.08 respectively whose particulars are given at Annexure 'A'.

However, other terms and conditions as already conveyed in the main selection list shall remain the same.
