1/ Whereas, the J&K Services Selection Board issued the select list of candidates for the post of "**Teacher**" (Education Department) District Cadre **Srinagar**, item No. 037 (01 of 2012 dated 19.07.2012) under Hon'ble Prime Minister's Special package for Kashmiri Migrants (pending posts). and forwarded to the Revenue Department vide letter No. SSB/Secy/Sel/2017/11258-65 dated 06.11.2017 for further course of action; and

2/ Whereas, among others, the recommendation of the candidate namely **Mohit Labroo S/o Tej Krishan Labroo** figuring at **S.No 13- Waiting** under OM category having total merit **40.2222 points** was **withheld and is subject to clarification with regard to validity of Grad and production of bonafide certificate thereof.**

3/ Whereas, the candidate has submitted Bonafide certificate of Graduation issued by the **Additional Registrar SIKKIM MANIPAL University** mentioning therein that the candidate has completed Bachelor of Computer Application during the year 2008 through private University U/S 2(F) of the UGC Act, 1956.; and

4/ Whereas, the matter was taken up with the University authorities vide this office letter No. SSB/Secy/Sel/2017/Mig/Sgr/V/2017/940 dated 22.01.2018 with the request to intimate whether the candidate namely **Mohit Labroo S/o Tej Krishan Labroo** has done his degree from main campus or off campus; and


5/ Whereas, in response, the Additional Registrar has intimated vide No. **SE/VD/1949/2018 dated 24.02.2018** that the Bonafide certificate issued to **Mohit Labroo bearing Reg. No. 520611013 of Bachelor of Computer Application (BCA)** programme has been verified from their records and found genuine. Further **Mr. Mohit Labroo** has done his **BCA** Program from **off campus** through their authorized learning centre

namely, SMMTR (School of Management, Media, Technological Sciences & Research). (LC Code: 01597) Kolkota West Bengal. Mode of study is **Distance Education**; and

6/ Whereas, the case was processed and it was decided that the candidate having Graduation in Distance Mode does not under the purview of Govt. Order No.252-HE of 2012 dated 30.05.2012, therefore two points may be deducted from over all merit of the above mentioned candidate; and

7/ Whereas, after deducting (02) points from overall merit of the candidate, the candidate shall now figure at **S.No. 38-Waiting** under OM category with revised merit position **38.2222 points**. Consequently the candidate earlier figuring at **S.No. 14-Waiting** under OM category shall now figure at **S.No.13-Waiting** under OM category so on and so forth upto **S.No. 38-waiting** under OM category who will now figure at **S.No. 37-waiting** under OM category.

In the backdrop of the situation enumerated hereinabove, the recommendation of the candidate namely **Mohit Labroo S/o Tej Krishan Labroo** is hereby released at **S.No.38-Waiting** under OM category as per terms and conditions already conveyed vide this office letter No. SSB/Secy/Sel/2017/11258-65 dated 06.11.2017.
