Subject:- SWP No. 46/2018 titled Mohd Munshi Vs state and Ors.


- 1) Whereas, the JK Services Selection Board vide advertisement Notification No. 02 of 2011 dated 28/12/2011 invited applications from eligible candidates for the post of PET, district cadre Srinagar; and
- 2) Whereas, the petitioner applied for the same post under district cadre Srinagar under ST category. In the final selection list, the petitioner has been shown selected under ST category. However, his recommendation was kept withheld subject to the production of the Bonafide Certificate/validity of C.Ped and valid sports certificate; and
- 3) Whereas, the petitioner was asked to furnish Bonafide certificates obtained by him from National Institute of vocational Education; and
- 4) Relevant documents have been submitted by the petitioner before the Board. Thereafter, Board took up the matter with the Secretary of Sports Council J&K vide letter dated 24/03/2017; and
- 5) Whereas, in response to letter dated 24/03/2017, the Sports Council of J&K vide letter dated 31/03/2017 intimated that Sports Certificate produced by the petitioner can be considered for the weight age. However, validity of C.Ped certificate submitted by the applicant can be confirmed from the Directorate of Youth Services and Sports Council/ University of Kashmir/ Jammu.
- 6) Whereas, again, vide letter dated 6/04/2017, issued regarding the validity of C.Ped certificate was

taken up with the Directorate of Youth Services and Sports Department.

- 7) Whereas, in response to communication dated 6/4/2017 from Board, Directorate of Youth Services and Sports Department vide letter 20/11/2017 responded that said certificate may be verified from the concerned Board/university; and
- 8) Whereas, matter was taken up with the National Institute of Vocational Education who vide letter dated 23/08/2017 has responded that the certificate is genuine according to their records; and
- 9) Whereas, during this course, the petitioner has approached the Hon'ble High Court through the medium of SWP No. 46/2018 and has sought directions from the Hon'ble High Court for releasing his recommendation for the post of Physical Education Teacher under item no 533 advertised vide notice no 02 of 2011 under ST category in district Srinagar.
- 10) Whereas, SWP No. 46/2018 has been finally disposed of by the Hon'ble High Court vide judgment dated 11/01/2018. The operative part of the judgment dated 11/01/2018 is reproduced as under:
- "Respondent no 2 shall do well to take a final decision in the matter and make appropriate recommendations to respondent no 1 within a period of four weeks from the date a certified copy of this order is served upon him. Needless to say that based upon the recommendations of respondent no 2, respondent no 1 shall pass appropriate order in favour of petitioner within two weeks thereafter.*
- With the aforesaid directions, this petition stands disposed of along with connected MPs"*
- 11) Whereas, extensive exercise was made by the Board which clarifies the position and there seems no cogent reason for not releasing the recommendation of the petitioner as his relevant documents stand already verified and authenticated by all the quarters.

Now, therefore the claim of the petitioner has been examined and considered in compliance to judgment dated

11/01/2018 passed by the Hon'ble High Court in SWP No. 46/2018 read with facts stated herein above, recommendation of the petitioner namely Shri Mohd. Munshi S/O Kalam Din R/O Sangri Khanmoh Village Androlla kalakote, Rajouri is hereby released for the post of PET in response to the advertisement notification no. 02 of 2011 dated 28/12/2011, item no. 533 under ST category at S.No 01, district cadre Srinagar. However, other terms and conditions shall remain same as conveyed in the original selection list issued by Board vide Letter No. SSB/Secy/Se1/2016/1538-44 dated 31/01/2017 in respect of post of PET for district cadre Srinagar.
