

Subject:- Select List of candidate for the posts of Inspector, Induscos, (industries & Commerce Department) Divisional Cadre Jammu advertised vide Advertisement Notice No 01 of 2011 dated 31-01-2011 Item No 106.

Sir,

- > That the Services Selection Board received an indent/ requisition from Industries and Commerce Department under Endorsement No:- IND/DOH/34/2008 dated 25-01-2011.
- > The Board advertised 01 (OM-01) post of Inspector, Induscos, (industries & Commerce Department) Divisional Cadre Jammu advertised vide Advertisement Notice No 01 of 2011 dated 31-01-2011 Item No 106.
- > That in response to the said advertisement notice short listing of the candidates in 1:5 ratio for interview was resorted to on the basis of academic merit in the basic prescribed qualification as per the Criteria approved by the Board.
- > The provisional select list of the candidates was published calling objections/claims from the interested candidates. The Selection Committee after giving due consideration to the representations (objections/claims) disposed of these representations on merits and finalized the select list. The said select list and disposal of the representations/claims was placed before the Board, which adopted the select list and directed the Secretary of the Board to forward the said recommendation to your department with such observations.
- > In the meantime the selection process was challenged in SWP No 1415/2012 in CMA No 2172/2012 dated 12-06-2012, Hon'ble High Court order as under:-
"On examination of the record coupled with the submission of the learned counsel for the petitioners, case is carved but for indulgence, as such, it is directed that selection/engagement of respondent no 4 shall remain in abeyance. Objections, if any, within notice period."
Now the Hon'ble High Court has dismissed the said writ petition alongwith connected CMP's as being without merit.
- > The undersigned is directed to enclose the select list/recommendation as Annexure "A", however, the select list shall be subject to outcome of any writ petition(s), if any, pending in any court of the competent jurisdiction.
- > That the Board is devoid of any fool proof mechanism/resources to verify the recognition status/genuineness of qualification/category certificates/ permanent resident certificate. Therefore, the indenting department shall have to verify position confidentially from the concerned Universities/ Institutions/departments.
- > You are further requested that in case any certificate/document during the course of verification turns out to be fake/fictitious, the Board may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
