Subject: - SWP No. 1625/2016 titled Pooja Sharma VS State and  
ors.

- 1) Whereas, the Services Selection Board forwarded a select list of candidates for the post of "Jr. Asstt." (School Education Department) in pursuance to advertisement no. 10 of 2013 dated 10/10/2013 under item no 883 (district cadre) Udhampur vide no. SSB/Secy/ Sel/016/2051-57 dated 08/02/2016 for further course of action and;
- 2) Whereas, petitioner had also applied for said post under OM category and participated in the selection process conducted by the Board; and
- 3) Whereas, after conclusion of the selection process, the petitioner was successful in securing place in the selection list and figured at S.No. 1 in the final selection under OM category and against her remarks it was reflected that **"recommendation withheld and is subject to production of Bonafide certificate/validity of Graduation and post marital PRC."**
- 4) Whereas, thereafter, petitioner through the medium of SWP No. 1625/2016 approached the Hon'ble High Court and sought directions for quashing requirement of post material permanent resident certificate on account of which the recommendation for appointment of the petitioner has been withheld, with a further direction to respondent no 1 and 2 to forward the name of the petitioner to respondent no 3 for issuing appointment order in her favour, etc; and
- 5) Whereas, in MP No. 01/2016 filed in SWP No. 1625/2016 the Hon'ble High Court vide Order dated 19/08/2016 issued the interim directions. The operative part of the Hon'ble Court order dated 19/08/2016 is reproduced as under:



*"...As ad interim and subject and objections, respondents 1 and 2, the SSB shall finalize the selection of the petitioner and take appropriate decision without delay, preferably within four weeks after petitioner produces a copy of this order in the office of respondent No. 1"*


- 6) Whereas, the Hon'ble High Court vide judgment dated 24/04/2018 has been pleased to dispose of the writ petition No. 1625/2016. The operative part of the judgment dated 24/04/2016 is reproduced as under:

*"Keeping in view the certificates issued by the Additional Deputy Commissioner, Udhampur regarding the residence of the petitioner, wherein it is stated that the petitioner is residing for the last 15 years in the area of appointment, there is no impediment at all for making such recommendation in favour of the petitioner. This petition is allowed. Appropriate recommendations would be made by the Board to the Government within one weeks' from today positively. The respondent-department shall then issue appointment order in favour of the petitioner within two weeks thereafter".*

- 7) Whereas, in compliance with the judgment dated 24/04/2018, the petitioner submitted her documents/Bonafide and clarification regarding residential district issued by the Addl. Deputy Commissioner Udhampur vide No. 469/N dated 09/03/2016 for consideration and matter been examined and considered for the release of the recommendation of the petitioner and it was found that petitioners claim merits consideration; and

Now, therefore, in compliance to the judgment of the Hon'ble Court dated 24/04/2018 passed in SWP No. 1625/2016, coupled with the facts stated herein above, recommendation in favour of petitioner namely Pooja Sharma W/O Anil Vaid R/O Near BDO office kallar Udhampur figuring at S. No 01/OM for the post of Junior Assistant. (School Education Department) in pursuance to Advertisement Notification no 10 of 2013, under item no 883, (distict cadre) Udhampur is hereby released. The indenting department (School Education Department) shall verify the Bonafide certificate and validity of the Graduation with the concerned institution and in accordance with the Government order of 252 and other rules in vogue. Rest of the other terms an

conditions as conveyed in the main selection list shall remain the same.
