

- Against indent No. Rev/NG/Vacancies/131/2013 Dated: - 02-04-2013, Board advertised 03 posts (OM=01, RBA=01, SC=01) of "Driver", District Cadre Baramulla, in pursuance to the advertisement notification 06 of 2013, Dated: - 10-05-2013 (Item No. 397), the Select list for the said item is hereby enclosed as (Annexure "A"). Therefore, the indenting department shall have to verify all credentials/certificates as per codal formalities confidentially before issuing appointment orders in respect of the selected candidates.
