1. Whereas, the J&K Services Selection Board conducted written examination for the posts of General Teacher (District Cadre Anantnag and Baramulla), Advt No 06 of 2017, on 13<sup>th</sup> May, 2018 (**Sunday**); and
2. Whereas, a link was activated on the official website of Board, subsequently, for sharing the Answer Keys of different sets along with the provision of submitting representations, if any, against the key, regarding the correctness of the key;
3. Whereas, a total of 62 unique representations were received within the stipulated time in respect of the above mentioned exam. Upon examination of the representations by the experts, it has been found that there are only four questions wherein the answers are required to be corrected, in comparison to the declared Answer Key. The said changes are shown as under-

- i) Questions where the Answering options are to be changed are as under:-

awarded marks. However, no marks will be awarded to the candidates opting for both the options.

Further, it is being brought to the notice of the candidates that there shall be no Viva and the shortlisting will be made purely as per notified criteria, together with the merit of the candidates, acquired in the Written test
