Subject- Revised/Final Answer Key of the OMR Based Objective Type Written Examination for the posts of Assistant Storekeeper cum Clerk, Divisional Cadre Kashmir, Advertised vide Notification No. 03 of 2017 under Item No 01, held on 12<sup>th</sup> May 2018, (Saturday) after disposal of the representations- regarding.

1. Whereas, the J&K Services Selection Board conducted written examination for the posts of Assistant Storekeeper cum Clerk, Divisional Cadre Kashmir, Advertised vide Notification No. 03 of 2017 under Item No 01, on 12<sup>th</sup> May 2018, (Saturday); and
2. Whereas, a link was activated on the official website of Board, subsequently, for sharing the Answer Keys of different sets along with the provision of submitting representations, if any, against the key, regarding the correctness of the key;
3. Whereas, a total of 120 unique representations were received within the stipulated time in respect of the above mentioned exam. Upon examination of the representations by the experts, it has been found that there are only three questions wherein the answers are required to be corrected, in comparison to the declared Answer Key. The said changes are shown as under-

- i) Questions where the Answering options are to be changed are as under:-

- ii) Questions where Two Answering Options are correct:-

It may be noted here that candidates having marked either of the options as Answering Option for the questions where two Answering Options are correct, will be awarded marks. However, no marks will be awarded to the candidates opting for both the options.

The result will be prepared as per the revised key, accordingly.

Further, it is being brought to the notice of the candidates that there shall be no Viva and the shortlisting will be made purely as per notified criteria, together with the merit of the candidates, acquired in the Written test
