Subject: Exemption from multiple document verification and counselling sessions for Scheduled Caste (SC) candidates.

Order No.399-SSB of 2018
Dated.24.08.2018

Whereas, pursuant to various advertisements issued by the Board from time to time in respect of posts of Science, Math, Urdu and General Teachers, provisional shortlists for various districts were issued.

Whereas, the candidates so shortlisted for various districts of Kashmir Province have been called for counselling and document verification at Central Office, J&K Services Selection Board, Zum Zum Complex, Rambagh, Srinagar, inter-alia, mandating their personal appearance;

Whereas, scores of candidates of Jammu Province belonging to the Scheduled Caste (SC) category shortlisted for General Teacher posts, in different districts of Kashmir Province have represented for exemption from multiple document verifications/counselling sessions, on the grounds that it is very inconvenient for them to present themselves before the Board office at Srinagar for the same post again and again;


Whereas, the issue was examined and it came to fore that there are indeed a number of candidates of Jammu Province in Scheduled Caste category, who have figured in provisional shortlists for various districts of Kashmir Province for the posts of General Teacher;

Whereas, it was felt that the process in its present form, not only causes avoidable inconvenience to the candidates but also results in undue overburdening of

the Board as the document verification and counselling of the same candidate for the same post needs to be carried out multiple times;

Now, therefore, keeping in view the above mentioned facts and circumstances, it is hereby ordered that such candidates of Jammu Province belonging to Scheduled Caste category, shortlisted for the General Teacher posts in different districts of Kashmir Province shall, henceforth, present themselves for document verification/counselling once only at the beginning of such process and schedule and this one time presentation before the Board shall be deemed to be valid for the same post for the other districts of the Kashmir Province also, where the candidate is shortlisted in. However, such candidates shall be required to furnish a notarized affidavit clearly specifying their preferences for consideration in respect of various districts of Kashmir Province for the said post, before the Secretary, J&K Services Selection Board.
