
- 1) **Whereas**, consequent upon indent placed by the Forest Department vide its No. FST/Coord/54/SF-Vacancy/ 2011 dated 15.11.2012 the Board had notified 16 posts of Social Forestry Worker Divisional cadre Kashmir in terms of Advertisement notification No 03 of 2012 dated 28.12.2012 with the category wise breakup as under:-
OM=11, RBA=02, SC=01, ST=01 and OSC=01;
- 2) **Whereas**, the selection process commenced and a provisional selected list of 16 candidates came to be approved in terms of SOP notified by the Board; and
- 3) **Whereas**, before the selected list so framed could be forwarded to the Forest Department, it came to fore that a revised indent vide No. FST/Coord/54/SF- Vacancies/2011 dated 04.02.2013 had been furnished by the said Department with a modified category wise break up as under:-
OM=08, RBA=03, SC=02, ST=02 and ALC=01;
- 4) **Whereas**, the issue was discussed in the 140th meeting of the J&KSSB and it was decided that a revised/ modified selected list shall be framed in light of the revised indent of the Forest Department.

Now, therefore, in pursuance to the provisions contained in J&K Services Selection Board Conduct of Examination Regulations, 2013 issued vide Government Order No. 1465 – GAD of 2013 dated 15.10.2013 as well as the approval of the Board;

- (i) The revised selected list for the post of (**Social Forestry Worker**,) advertised under Item No. (185), Notification No. (03 of 2012) dated (28.12.2012) is hereby notified as **Annexure-“A”**.
- (ii) The selection list comprises of 14 candidates under OM=08, RBA=03, SC=01 and ST=02 categories alongwith waiting list of 05 candidates under Open Merit and 01 candidate under RBA category.
- (iii) 01 post of ALC & 01 post of SC category remained unfilled due to non-availability of the eligible candidates.
- (iv) The list notified shall be subject to the outcome of writ petition(s) (if any) pending disposal before any Competent Court of jurisdiction/forum.
- 5) The document verification/scrutiny by the Board is limited to the extent of establishing physical possession of category /degree certificate in

reference of advertised notification and establishing the genuineness/validity or otherwise of the same shall be responsibility of the appointing authority.

- 6) You are further requested that in case any certificate/document during the course of verification turns out to be fictitious, the board may kindly be kept posted and appropriate criminal proceeding against such candidates may please be initiated.
