Whereas, (Forest Department) vide indent No. (FST/Coord/69/2012) dated 18.02.2013 referred (32) posts of Forest Guard with category breakup of (OM=20, RBA=06, SC=02, ST=03 and ALC=01) in District Cadre Baramulla to the J&K Services Selection Board for selection; and

Whereas, the posts were advertised by the Board vide Notification No. 04 of 2013 dated 23-02-2013 and selection process in respect of the same commenced and a provisional short list of the candidate(s) was published by the Board on 14-02-2018 and the said candidates was/were called for document verification/Counseling.

Whereas, the Board conducted the Document Verification-cum-Counseling of the provisionally shortlisted candidates on 06-03-2018 & 07.03.2018 as per the schedule published/uploaded on official website and a select list of 29 candidates was framed/finalized and approved in terms of the SOP of the Board; and

Whereas, before said selection list could be forwarded to the Indenting Department, it came to fore, that the matter was sub-judice and the Hon'ble High Court in SWP No. 1609/2018 titled Mohammad Yousuf Sofi and others V/s State & others had passed an interim order dated 18.07.2018 for reserving 02 posts of Forest Guard from the Open Merit Category; and

Whereas, the matter was placed in the 140th Board meeting for appropriate consideration in light of the interim order of the Hon'ble High Court; and wherein, the Board decided to reserve 02 posts of Forest Guards from the Open Merit Category in compliance to the aforementioned order of the Hon'ble High Court.

Now, therefore, in pursuance to the provisions contained in J&K Services Selection Board Conduct of Examination Regulations, 2013 issued vide Government Order No. 1465 – GAD of 2013 dated 15.10.2013 as well as the approval of the Board;

- (i) The final selection list for the post of (Forest Guard) advertised under Item No. (305), Notification No. (04 of 2013) dated (23.02.2013) is hereby notified as Annexure-"A".



- (vi) The list notified shall be subject to the outcome of writ petition(s) (if any) pending disposal before any Competent Court of jurisdiction/forum.

The documents verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree certificate in reference of advertised notification and establishing the genuineness/validity or otherwise of the same shall be responsibility of appointing authority.

You are further requested that in case any certificate/document during the course of verification turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceedings against such candidates may please be initiated.
