Whereas, the select list of the candidates who had participated in Counseling/Document verification process, was approved by the Board in its 141st meeting and was uploaded on the official website of JKSSB.

Whereas, document verification of the shortlisted candidates was scheduled on 22-02-2018 at Central office, Srinagar. However, her document verification and counseling had been carried out at Jammu on 21-02-2018 on health grounds.

Whereas, the claim of the candidate was thus based on merit and the selection list earlier approved by the Board in respect of SC category was required to be modified.

Whereas, the matter was again placed in 143rd meeting of the Board of JKSSB and a revised select list of the candidates for the SC category was approved.
