Sub:- Cancellation of candidature of candidates for the post of “Accounts Assistant” (Finance Department) District Cadres Bandipora, Baramulla, Ganderbal, Kulgam, Shopian and Srinagar pursuant to advertisement Notification No. 07 of 2010 against item Nos. 398, 399, 395, 400, 393 and 396 (07 of 2010) respectively.

Reference: Decision of 143<sup>rd</sup> of meeting of Board of JKSSB.

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of “Accounts Assistant” (Finance Department) District Cadres Bandipora, Baramulla, Ganderbal, Kulgam, Shopian and Srinagar pursuant to advertisement Notification No. 07 of 2010 against item Nos. 398, 399, 395, 400, 393 and 396 respectively and recommended the same to the Finance Department vide letter No.SSB/Secy/Sel/2017/11907-13 dated 22.11.2017, No.SSB/Secy/Sel/2017/11985-91 dated 21.11.2017 and No. No.SSB/ Secy/ Sel/ 2017/13256-62 dated 15.12.2017 for further course of action; and

2/ Whereas, the recommendations in respect of some candidates had been kept withheld for certain clarifications and furnishing of deficient documents and the candidates were called by the Board on 29<sup>th</sup> and 30<sup>th</sup> January, 2018 through a special Drive to clear their deficiencies, but they failed to attend the same; and

3/ Whereas, thereafter the said candidates were again served a notice vide this office No. SSB/Secy/Sel/18/2971-73 dated 23.03.2018 asking them to furnish the requisite documents within 12 days from the date of issuance of the said notice failing which their selection/recommendation against the said posts will be cancelled without further notices; but they failed to respond.

4/ Whereas, the said candidates were thereafter served a final notice vide this office No. SSB/Secy/Sel/18/5563-65 dated 04.06.2018. Therefore asking them to furnish the requisite documents within 21 days from the date of issuance of the

said notice failing which their selection/recommendation against the said posts shall be cancelled without further notices; and

5/ Whereas, the said candidates again failed to furnish the requisite documents for release of their withheld recommendations for the posts under reference and it was presumed that they are not interested in getting appointed against the said posts and hence their candidature needs to be cancelled, so that waiting lists already forwarded to the department can be operated, if required.

6/ Whereas, the matter was considered by the board in its 143<sup>rd</sup> meeting wherein it was decided that recommendations in respect of these candidates who have failed to respond to repeated notices of the Board for clearing their deficiencies be cancelled so that the deserving candidates in the waiting list get a chance.

7/ Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidates given at annexure "A" of this notice is cancelled/withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required.
