Subject:- Cancellation of candidature of candidate for the post of "Accounts Assistant" (Finance Department) District cadre Kishtwar, item No.715(07 of 2010).

Reference: Decision of 144th of meeting of Board of JKSSB.


- 1) Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Accounts Assistant" (Finance Department) District cadre, Kishtwar, item No.715(07 of 2010) and recommended the same to the Finance Department) district cadre Kishtwar, vide letter No.SSB/Secy/Sel/2017/1985-91 dated 21-11-2017 for further course of action; and
- 2) Whereas, amongst others, the recommendation of one candidate namely **Tenzen Sambial S/O Rinzen Dorjay figuring at S.No. 02 under ST category** had kept withheld for want of certain clarification/furnishing of documents
- 3) Whereas, the said candidate was served a notice vide this office No.SSB/Secy/Sel/2018/1464-66 dated 06-02-2016 to furnish the requisite documents within 10 days, failing which the withheld recommendation against the said posts will be cancelled on the sole risk and responsibility of the candidate, but the candidate did not submit the same; and
- 4) Whereas, thereafter the said candidate was served a final another notice vide this office No.SSB/Secy/Sel/2018/2667-69 dated 13-03-2018 asking him to furnish the requested documents within 15 days failing which his selection against the said post shall be cancelled without further notices; and
- 5) Whereas, the said candidate ~~was~~ again failed to furnish the requisite documents for release of his withheld recommendation for the post under reference and it was presumed that he is not interested in getting appointed against the said post.

and hence his candidature needs to be cancelled, so that waiting lists already forwarded to the department can be operated, if required.

6) Whereas, the matter was considered by the Board in its 144th meeting wherein it was decided that recommendation in respect of the above said candidate be cancelled so that the deserving candidate in the waiting list get a chance of employment.


7) Now, therefore, in view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Tenzen Sambial S/O Rinzen Dorjay** figuring at S.No. 02 under ST category is cancelled/withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required.
