
ORDER NO. 480-SSB of 2018

Sub:- Cancellation of candidature of candidates for the post of "**Field Assistant**" (Agriculture Production Department) Divisional Cadre Kashmir, pursuant to advertisement Notification No. 01 of 2011 item No. 308.

Reference: Decision of **145<sup>th</sup>** meeting of Board of JKSSB.

- 1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Field Assistant**" (Agriculture Production Department) Divisional Cadre Kashmir, pursuant to advertisement Notification No. 01 of 2011 item No. 308 and recommended the same to the Agriculture Production Department vide letter No.SSB/ Secy/ Sel/2017/13182-88 dated 14.12.2017; and
- 2/ Whereas, the recommendation in respect of one candidate namely **Zafar Iqbal Buhroo S/o Gulam Mohiuddin Buhroo figuring at S.No.03 under OM category** was kept withheld for production of Bonafide certificate of Post Graduation and the candidate was called by the Board on 29<sup>th</sup> and 30<sup>th</sup> January, 2018 through a special document submission session to clear his deficiencies, but he failed to attend the same; and
- 3/ Whereas, the said candidate was served a notice vide this office No. SSB/Secy/Sel/Sel/270/7700-03 dated 03.07.2018 asking him to furnish the requisite documents within 21 days from the date of issuance of the said notice failing which the selection/recommendation against the shall be cancelled without further notices; and
- 5/ Whereas, in response, the candidate has submitted an undertaking in the shape of an affidavit duly attested by Judicial Magistrate Ist Class, Srinagar stating therein that he is not interested in joining against the said post; and
- 6/ Whereas, the matter was considered by the Board in its **145<sup>th</sup>** meeting wherein it was decided that the candidature/selection of the above said be cancelled so that the deserving candidate against the post of Field Assistant in the waiting list get a chance of employment.

7/ Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Zafar Iqbal Buhroo S/o Gulam Mohiuddin Buhroo figuring at S.No.03 under OM category** for the post of "**Field Assistant**" (Agriculture Production Department) Divisional Cadre Kashmir, pursuant to advertisement Notification No. 01 of 2011 item No. 308 is cancelled/ withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required.
