Subject:- Rescinding the selection lists for the post of Carpenter, Plumber, Electrician and Pump Operator (Tourism Department), State Cadre.

Whereas, the Tourism Department vide letter No. TSM/Estt-94/2005 dated 24/05/2011 furnished an indent for six (06) posts of Assistant Tourist Officer, one (01) post of Jr. Yatchman, one (01) post of Pump Operator, two (02) posts of driver, one (01) post of Electrician, one (01) post of carpenter and one (01) post of Plumber;

Whereas, through a different letter dated TSM/Estt-94/2005 dated 26/04/2013 the same set of posts were re-referred to the Board after excluding six (06) posts of ATO's for recruitment;

Whereas, the Board has presumably perceived the re-referral as a fresh indent and advertised the posts twice through two (02) different advertisements 03 of 2012 and 07 of 2013;

Whereas, the selection process in respect of both the advertisements commenced and final selection list were drawn and forwarded to the indenting department;


Whereas, the indenting department after receiving excess selections in respect of the posts of Carpenter, Plumber, Electrician and Pump Operator took up the matter with General Administration Department (GAD) for opinion,

Whereas, the opinion of the GAD was conveyed to the Board through a letter dated 18-05-2018 for which a clarification was sought and received in the Board through a letter dated 19-11-2018;

Whereas, in light of the opinion of the GAD, The Tourism Department has requested for rescinding ab-initio the excess selections made in respect of the posts of Plumber, Electrician, Pump Operator and Carpenter;

Whereas, the matter was discussed in its entirety in the 144th and 146th meeting of the Board of JKSSB and it was decided that in light of the opinion of the GAD the excess selections made for the posts of Plumber, Electrician, Pump Operator and Carpenter be cancelled and the communications conveying the selections be rescinded ab-initio;

Now, therefore in light of the background narrated herein above the selections made in respect of the post of Plumber as conveyed vide letter No. SSB/Secy/Sel/2018/2524-30 dated 01/03/2017, Electrician as conveyed vide letter No. SSB/Secy/Sel/2018/1783-89 dated 19/02/2018, Pump Operator as conveyed vide letter No. SSB/Secy/Sel/2018/4477-84 dated 23/04/2018 and Carpenter as conveyed vide letter No. SSB/Secy/Sel/2018/5227-33 dated 09/06/2017 to the indenting department are cancelled and the aforementioned communications conveying the selections are rescinded ab-initio.
